AN ACT

To amend title 38, United States Code, to establish a Center for Women Veterans in the Department of Veterans Affairs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CENTER FOR WOMEN VETERANS.**

4 (a) IN GENERAL.—(1) Chapter 3 of title 38, United
5 States Code, is amended by adding at the end the follow-
6 ing new section:

1 **“§ 318. Center for Women Veterans**

2 “(a) There is in the Department a Center for Women
3 Veterans. There is at the head of the Center a Director.

4 “(b) The Director shall be a noncareer appointee in
5 the Senior Executive Service. The Director shall be ap-
6 pointed for a term of six years.

7 “(c) The Director reports directly to the Secretary
8 or the Deputy Secretary concerning the activities of the
9 Center.

10 “(d) The Director shall perform the following func-
11 tions with respect to veterans who are women:

12 “(1) Serve as principal adviser to the Secretary
13 on the adoption and implementation of policies and
14 programs affecting veterans who are women.

15 “(2) Make recommendations to the Secretary,
16 the Under Secretary for Health, the Under Sec-
17 retary for Benefits, and other Department officials
18 for the establishment or improvement of programs in
19 the Department for which veterans who are women
20 are eligible.

21 “(3) Promote the use of benefits authorized by
22 this title by veterans who are women and the con-
23 duct of outreach activities to veterans who are
24 women, in conjunction with outreach activities car-
25 ried out under chapter 77 of this title.

1 “(4) Disseminate information and serve as a re-
2 source center for the exchange of information re-
3 garding innovative and successful programs which
4 improve the services available to veterans who are
5 women.

6 “(5) Conduct and sponsor appropriate social
7 and demographic research on the needs of veterans
8 who are women and the extent to which programs
9 authorized under this title meet the needs of those
10 veterans, without regard to any law concerning the
11 collection of information from the public.

12 “(6) Analyze and evaluate complaints made by
13 or on behalf of veterans who are women about the
14 adequacy and timeliness of services provided by the
15 Department and advise the appropriate official of
16 the Department of the results of such analysis or
17 evaluation.

18 “(7) Consult with, and provide assistance and
19 information to, officials responsible for administering
20 Federal, State, local, and private programs that as-
21 sist veterans, to encourage those officials to adopt
22 policies which promote the use of those programs by
23 veterans who are women.

1 “(8) Advise the Secretary when laws or policies
2 have the effect of discouraging the use of benefits by
3 veterans who are women.

4 “(9) Publicize the results of medical research
5 which are of particular significance to veterans who
6 are women.

7 “(10) Advise the Secretary and other appro-
8 priate officials on the effectiveness of the Depart-
9 ment’s efforts to accomplish the goals of section
10 492B of the Public Health Service Act (relating to
11 the inclusion of women and minorities in clinical re-
12 search) and of particular health conditions affecting
13 womens’ health which should be studied as part of
14 the Department’s medical research program and
15 promote cooperation between the Department and
16 other sponsors of medical research of potential bene-
17 fit to veterans who are women.

18 “(11) Provide support and administrative serv-
19 ices to the Advisory Committee on Women Veterans
20 established under section 542 of this title.

21 “(12) Perform such other duties consistent with
22 this section as the Secretary shall prescribe.

23 “(e) The Secretary shall ensure that the Director is
24 furnished sufficient resources to enable the Director to
25 carry out the functions of the Center in a timely manner.

1 “(f) The Secretary shall include in documents sub-
2 mitted to Congress by the Secretary in support of the
3 President’s budget for each fiscal year—

4 “(1) detailed information on the budget for the
5 Center;

6 “(2) the Secretary’s opinion as to whether the
7 resources (including the number of employees) pro-
8 posed in the budget for that fiscal year are adequate
9 to enable the Center to comply with its statutory
10 and regulatory duties; and

11 “(3) a report on the activities and significant
12 accomplishments of the Center during the preceding
13 fiscal year.”.

14 (2) The table of sections at the beginning of such
15 chapter is amended by adding at the end the following
16 new item:

“318. Center for Women Veterans.”.

17 (b) CONFORMING AMENDMENT.—Section 317(c) of
18 such title is amended—

19 (1) by striking out “who is—” and inserting in
20 lieu thereof “who is any of the following:”;

21 (2) by striking out the semicolon at the end of
22 paragraphs (1) through (4) and inserting in lieu
23 thereof a period;

24 (3) by striking out “; or” at the end of para-
25 graph (5) and inserting in lieu thereof a period; and

1 (4) by striking out paragraph (6).

2 **SEC. 2. MEETINGS OF ADVISORY COMMITTEE ON WOMEN**
3 **VETERANS.**

4 Section 542(a) of title 38, United States Code, is
5 amended by adding at the end the following:

6 “(4) The Committee shall meet as often as the Sec-
7 retary considers necessary or appropriate, but not less
8 often than twice each fiscal year.”.
