Mr. INOUE introduced the following bill; which was read twice and referred to the Committee on Agriculture, Nutrition, and Forestry

A BILL

To waive certain limitations on assistance for losses resulting from Hurricane Andrew, Typhoon Omar, or Hurricane Iniki, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. WAIVER OF LIMITATIONS.**

4 (a) IN GENERAL.—In the case of losses incurred dur-
5 ing the 1992 and subsequent crop years as a result of
6 Hurricane Andrew, Typhoon Omar, or Hurricane Iniki,
7 funds appropriated under this or any other Act shall be
8 available to cover the losses without regard to—

9 (1) in the case of emergency crop loss assist-
10 ance provided under the terms and conditions of

1 chapter 3 of subtitle B of the Food, Agriculture,
2 Conservation, and Trade Act of 1990 (7 U.S.C.
3 1421 note), the limitations specified in sections
4 2249, 2255(b), 2257, and 2266 of such Act and the
5 500 acre limitation specified in section 2258 of such
6 Act; and

7 (2) any limitation under a program adminis-
8 tered by the Secretary of Agriculture for which the
9 Secretary grants a waiver.

10 (b) RURAL DWELLINGS.—Low-income families (as
11 defined in section 3(b)(2) of the United States Housing
12 Act of 1937 (42 U.S.C. 1437a(b)(2)) shall be eligible for
13 loans and grants for repairs or improvements of rural
14 dwellings provided under section 338 of the Housing Act
15 of 1949 (42 U.S.C. 1474) for losses described in sub-
16 section (a).

17 (c) HAZARD MITIGATION.—Section 204 of the Omni-
18 bus Insular Areas Act of 1992 (42 U.S.C. 5204c) shall
19 apply to the State of Hawaii with respect to assistance
20 for hazard mitigation provided for losses described in sub-
21 section (a).

22 (d) BUDGETARY TREATMENT.—

23 (1) IN GENERAL.—Except as provided in para-
24 graph (2), the entire amount required to carry out
25 this section is designated by Congress as an emer-

1 agency requirement pursuant to section
2 251(b)(2)(D)(i) of the Balanced Budget and Emer-
3 gency Deficit Control Act of 1985 (2 U.S.C.
4 901(b)(2)(D)(i)).

5 (2) BUDGET REQUEST.—The amount required
6 to carry out this section shall be available only to
7 the extent an official budget request, for a specific
8 dollar amount, that includes designation of the en-
9 tire amount of the request as an emergency require-
10 ment as defined in section 251 of such Act is trans-
11 mitted by the President to Congress.
