Mr. SIMON introduced the following bill; which was read twice and referred to the Committee on Finance

A BILL

To provide for the liquidation or reliquidation of certain entries of dog and cat treats as free of certain duties.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DUTY ON CERTAIN IMPORTATIONS OF DOG**

4 **AND CAT TREATS.**

5 (a) IN GENERAL.—Notwithstanding section 514 of
6 the Tariff Act of 1930 (19 U.S.C. 1514) or any other pro-
7 vision of law, the Secretary of the Treasury shall—

8 (1) liquidate or reliquidate without the imposi-
9 tion of duties set out in subheading 9903.23.35 any
10 entry described in subsection (b); and

1 (2) refund any such duties paid with respect to
2 any such entry.

3 (b) AFFECTED ENTRIES—The entries referred to in
4 subsection (a), filed in the Chicago Customs District with
5 filer code 353, are as follows:
