## A BILL

To amend chapter 17 of title 38, United States Code, to establish a program of rural health-care clinics, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

### 3   **SECTION 1. RURAL HEALTH-CARE CLINIC PROGRAM.**

4       (a) PROGRAM.—(1) Chapter 17 of title 38, United  
5       States Code, is amended by adding at the end of sub-  
6       chapter II the following new section:

1 **“§ 1720E. Rural health-care clinics: pilot program**

2       “(a) During the three-year period beginning on Octo-  
3 ber 1, 1993, the Secretary shall conduct a rural health-  
4 care clinic program in States where significant numbers  
5 of veterans reside in areas geographically remote from ex-  
6 isting health-care facilities (as determined by the Sec-  
7 retary). The Secretary shall conduct the program in ac-  
8 cordance with this section.

9       “(b)(1) In carrying out the rural health-care clinic  
10 program, the Secretary shall furnish medical services to  
11 the veterans described in subsection (c) through use of—

12               “(A) mobile health-care clinics equipped, oper-  
13 ated, and maintained by personnel of the Depart-  
14 ment; and

15               “(B) other types of rural clinics, including part-  
16 time stationary clinics for which the Secretary con-  
17 tracts and part-time stationary clinics operated by  
18 personnel of the Department.

19       “(2) The Secretary shall furnish services under the  
20 rural health-care clinic program in areas—

21               “(A) that are more than 100 miles from a De-  
22 partment general health-care facility; and

23               “(B) that are less than 100 miles from such a  
24 facility, if the Secretary determines that the furnish-  
25 ing of such services in such areas is appropriate.

1       “(c) A veteran eligible to receive medical services  
2 through rural health-care clinics under the program is any  
3 veteran eligible for medical services under section 1712 of  
4 this title.

5       “(d) The Secretary shall commence operation of at  
6 least three rural health-care clinics (at least one of which  
7 shall be a mobile health-care clinic) in each fiscal year of  
8 the program. The Secretary may not operate more than  
9 one mobile health-care clinic under the authority of this  
10 section in any State in any such fiscal year.

11       “(e) Not later than December 31, 1997, the Sec-  
12 retary shall submit to Congress a report containing an  
13 evaluation of the program. The report shall include the  
14 following:

15               “(1) A description of the program, including in-  
16 formation with respect to—

17                       “(A) the number and type of rural health-  
18 care clinics operated under the program;

19                       “(B) the States in which such clinics were  
20 operated;

21                       “(C) the medical services furnished under  
22 the program, including a detailed specification  
23 of the cost of such services;

24                       “(D) the veterans who were furnished serv-  
25 ices under the program, setting forth (i) the

1 numbers and percentages of the veterans who  
2 had service-connected disabilities, (ii) of the vet-  
3 erans having such disabilities, the numbers and  
4 percentages who were furnished care for such  
5 disabilities, (iii) the ages of the veterans, (iv)  
6 taking into account the veterans' past use of  
7 Department health-care facilities, an analysis of  
8 the extent to which the veterans would have re-  
9 ceived medical services from the Department  
10 outside the program and the types of services  
11 they would have received, and (v) the financial  
12 circumstances of the veterans; and

13 “(E) the types of personnel who furnished  
14 services to veterans under the program, includ-  
15 ing any difficulties in the recruitment or reten-  
16 tion of such personnel.

17 “(2) An assessment by the Secretary of the  
18 cost-effectiveness and efficiency of furnishing medi-  
19 cal services to veterans through various types of  
20 rural clinics (including mobile health-care clinics op-  
21 erated under the pilot program conducted pursuant  
22 to section 113 of the Veterans' Benefits and Services  
23 Act of 1988 (Public Law 100–322; 38 U.S.C. 1712  
24 note)).

1           “(3) Any plans for administrative action, and  
2           any recommendations for legislation, that the Sec-  
3           retary considers appropriate.

4           “(f) For the purposes of this section, the term ‘De-  
5           partment general health-care facility’ has the meaning  
6           given such term in section 1712A(i)(2) of this title.”.

7           (2) The table of sections at the beginning of such  
8           chapter is amended by inserting after the item relating  
9           to section 1720D the following new item:

          “1720E. Rural health-care clinics: pilot program.”.

10          (b) AUTHORIZATION OF APPROPRIATIONS.—(1)  
11       There is authorized to be appropriated to the Department  
12       of Veterans Affairs to carry out the rural health-care clin-  
13       ics program provided for in section 1720E of title 38,  
14       United States Code (as added by subsection (a)), the fol-  
15       lowing:

16               (A) For fiscal year 1994, \$3,000,000.

17               (B) For fiscal year 1995, \$6,000,000.

18               (C) For fiscal year 1996, \$9,000,000.

19          (2) Amounts appropriated pursuant to such author-  
20       ization may not be used for any other purpose.

21          (3) No funds may be expended to carry out the rural  
22       health-care clinics program provided for in such section  
23       1720E (as so added) unless expressly provided for in an  
24       appropriations Act.
