## A BILL

To suspend temporarily the duty on a-Isopropyl-a [(N-methyl-N-homoveratryl)-g-aminopropyl]-3, 4-Dimethoxyphenylacetonitril-hydrochloride.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. A-ISOPROPYL-A [(N-METHYL-N-HOMOVER-**  
4 **ATRYL)-G-AMINOPROPYL]-3, 4-DIMETHOXY-**  
5 **PHENYLACETONITRIL-HYDROCHLORIDE.**

6 (a) IN GENERAL.—Subchapter II of chapter 99 of  
7 the Harmonized Tariff Schedule of the United States is  
8 amended by inserting in numerical sequence the following  
9 new heading:

“	9902.31.12	a-Isopropyl-a [(N-methyl-N-homoveratryl)-g-aminopropyl]-3, 4-Dimethoxy-phenylacetonitril-hydrochloride. (CAS No. 152-11-4) (provided for in sub-heading 2926.90.35)	Free	No change	No change	On or before 12/31/97	”.

1 (b) EFFECTIVE DATE.—

2 (1) IN GENERAL.—The amendment made by  
3 subsection (a) applies with respect to goods entered,  
4 or withdrawn from warehouse for consumption, on  
5 or after the 15th day after the date of the enact-  
6 ment of this Act.

7 (2) RETROACTIVE APPLICATION TO CERTAIN  
8 ENTRIES.—Notwithstanding section 514 of the Tar-  
9 iff Act of 1930 (19 U.S.C. 1514) or any other provi-  
10 sion of law, upon proper request filed with the ap-  
11 propriate customs officer before the 90th day after  
12 the date of the enactment of this Act, any entry, or  
13 withdrawal from warehouse for consumption, of any  
14 goods described in heading 9902.31.12 of the Har-  
15 monized Tariff Schedule of the United States (as  
16 added by subsection (a)) that was made—

17 (A) after December 31, 1992; and

18 (B) before the 15th day after the date of  
19 the enactment of this Act;

1        shall be liquidated or reliquidated as though such  
2        entry or withdrawal occurred on the 15th day after  
3        the date of the enactment of this Act.
