Condemning the extraconstitutional and antidemocratic actions of President
Serrano of Guatemala.

IN THE SENATE OF THE UNITED STATES

MAY 26 (legislative day, APRIL 19), 1993

Mr. BINGAMAN (for himself, Mr. HARKIN, Mr. FORD, Mr. KENNEDY, Mr. KERRY, Mr. LEAHY, Mr. DOMENICI, and Mr. JEFFORDS) submitted the following resolution; which was referred to the Committee on Foreign Relations

RESOLUTION

Condemning the extraconstitutional and antidemocratic
actions of President Serrano of Guatemala.

Whereas Guatemala has had a democratically elected government since 1985;

Whereas President Jorge Serrano and the members of the Guatemalan Congress were freely and fairly elected;

Whereas on May 25, 1993, President Serrano seized near-dictatorial powers by partially suspending Guatemala's Constitution, dissolving Congress and the Supreme Court, and ruling by decree;

Whereas these events are extraconstitutional and antidemocratic and require immediate international attention and action; and

Whereas the Organization of American States agreed in Santiago, Chile, in 1991 to convene an emergency meeting of the Hemisphere's foreign ministers in the event of a coup d'etat in a member country in order to consider joint actions to bring about a return to democracy in that country: Now, therefore, be it

1 *Resolved*, That the Senate—

2 (1) condemns the extraconstitutional and anti-
3 democratic actions of President Serrano of Guate-
4 mala and considers those actions a serious blow to
5 democracy in Guatemala and a serious threat to de-
6 mocracy in the Hemisphere;

7 (2) calls on President Serrano to restore imme-
8 diately the democratically elected Congress and the
9 judiciary and to ensure full respect for internation-
10 ally recognized human rights;

11 (3) commends President Clinton for his rapid
12 and decisive response to the situation in Guatemala,
13 in particular his condemnation of President
14 Serrano's actions and his suspension of disburse-
15 ments of United States assistance;

16 (4) calls on the President to suspend the Unit-
17 ed States assistance program to Guatemala, and to
18 seek to delay approval of any international loans for
19 Guatemala, until constitutional government is re-
20 stored to Guatemala; and

1 (5) commends the Organization of American
2 States (OAS) for its plan to send a fact-finding mis-
3 sion headed by the Secretary General to Guatemala
4 and for calling a meeting of the foreign ministers of
5 the OAS member countries, to be held within 10
6 days.

7 SEC. 2. The Secretary of the Senate shall transmit
8 a copy of this resolution to the President of the United
9 States.
