Mrs. KASSEBAUM (for herself, Mr. INOUYE, Mr. DASCHLE, Mr. DODD, Mr. LUGAR, Mr. McCAIN, Mr. PELL, Mr. GORTON, Mr. SIMON, Mr. COHEN, and Mr. NUNN) submitted the following resolution; which was read twice and referred to the Committee on Rules and Administration

RESOLUTION

To amend the rules of the Senate to improve legislative efficiency, and for other purposes.

1 *Resolved*, That rule XXV of the Standing Rules of
2 the Senate is amended to read as follows:
3 “STANDING COMMITTEES
4 “1. The following standing committees shall be ap-
5 pointed at the commencement of each Congress, and shall
6 continue and have the power to act until their successors
7 are appointed, with leave to report by bill or otherwise on
8 matters within their respective jurisdictions:

1 “(a)(1) **Committee on National Priorities**, to
2 which committee shall be referred all concurrent resolu-
3 tions on the budget (as defined in section 3(a)(4) of the
4 Congressional Budget Act of 1974) and all other matters
5 required to be referred to committee under titles III and
6 IV of that Act, and messages, petitions, memorials, and
7 other matters relating thereto.

8 “(2) Such committee shall have the duty—

9 “(A) to report the matters required to be re-
10 ported by committee under titles III and IV of the
11 Congressional Budget Act of 1974;

12 “(B) to make continuing studies of the effect
13 on budget outlays of relevant existing and proposed
14 legislation and to report the results of such studies
15 to the Senate on a recurring basis;

16 “(C) to request and evaluate continuing studies
17 of tax expenditures, to devise methods of coordinat-
18 ing tax expenditures, policies, and programs with di-
19 rect budget outlays, and to report the results of such
20 studies to the Senate on a recurring basis; and

21 “(D) to review, on a continuing basis, the con-
22 duct by the Congressional Budget Office of its func-
23 tions and duties.

24 “(b)(1) **Committee on Agricultural Policy**,
25 to which committee shall be referred all proposed legisla-

1 tion, messages, petitions, memorials, and other matters re-
2 lating primarily to the following subjects:

3 "1. Agricultural economics and research.

4 "2. Agricultural extension services and experiment
5 stations.

6 "3. Agricultural production, marketing, and stabiliza-
7 tion of prices.

8 "4. Agriculture and agricultural commodities.

9 "5. Animal industry and diseases.

10 "6. Crop insurance and soil conservation.

11 "7. Farm credit and farm security.

12 "8. Food from fresh waters.

13 "9. Inspection of livestock, meat, and agricultural
14 products.

15 "10. Pests and pesticides.

16 "11. Plant industry, soils, and agricultural engineer-
17 ing.

18 "12. Rural development, rural electrification, and
19 watersheds.

20 "(2) There shall also be referred to such committee
21 all proposed legislation, messages, petitions, memorials,
22 and other matters relating to the appropriation, or to the
23 rescission of the appropriation, of revenue for the support
24 of Government programs, projects, or activities relating

1 primarily to the subjects specified in paragraph (b)(1), ex-
2 cept as provided in subparagraph (a).

3 “(c)(1) **Committee on Defense Policy**, to
4 which committee shall be referred all proposed legislation,
5 messages, petitions, memorials, and other matters relating
6 primarily to the following subjects:

7 “1. Aeronautical and space activities peculiar to or
8 primarily associated with the development of weapons sys-
9 tems or military operations.

10 “2. Common defense.

11 “3. Department of Defense, the Department of the
12 Army, the Department of the Navy, and the Department
13 of the Air Force, generally.

14 “4. Maintenance and operation of the Panama Canal,
15 including administration, sanitation, and government of
16 the Canal Zone.

17 “5. Military research and development.

18 “6. National security aspects of nuclear energy.

19 “7. Naval petroleum reserves, except those in Alaska.

20 “8. Pay, promotion, retirement, and other benefits
21 and privileges of members of the Armed Forces, including
22 overseas education of civilian and military dependents.

23 “9. Selective Service system.

24 “10. Strategic and critical materials necessary for the
25 common defense.

1 “(2) There shall also be referred to such committee
2 all proposed legislation, messages, petitions, memorials,
3 and other matters relating to the appropriation, or to the
4 rescission of the appropriation, of revenue for the support
5 of Government programs, projects, or activities relating
6 primarily to the subjects specified in paragraph (c)(1), ex-
7 cept as provided in subparagraph (a).

8 “(d)(1) **Committee on Commercial Policy**, to
9 which committee shall be referred all proposed legislation,
10 messages, petitions, memorials, and other matters relating
11 primarily to the following subjects:

- 12 “1. Coast Guard.
- 13 “2. Coastal zone management.
- 14 “3. Communications.
- 15 “4. Construction and maintenance of highways, and
16 highway safety.
- 17 “5. Inland waterways, except construction.
- 18 “6. Interstate commerce.
- 19 “7. Marine and ocean navigation, safety, and trans-
20 portation, including navigational aspects of deepwater
21 ports.
- 22 “8. Marine fisheries.
- 23 “9. Merchant marine and navigation.
- 24 “10. Nonmilitary aeronautical and space sciences.
- 25 “11. Oceans, weather, and atmospheric activities.

1 “12. Regulation of consumer products and services,
2 including testing related to toxic substances, other than
3 pesticides.

4 “13. Regulation of interstate common carriers, in-
5 cluding railroads, buses, trucks, vessels, pipelines, and
6 civil aviation.

7 “14. Science, engineering, and technology research
8 and development and policy.

9 “15. Sports.

10 “16. Standards and measurement.

11 “17. Transportation.

12 “18. Transportation and commerce aspects of Outer
13 Continental Shelf lands.

14 “19. Regional economic development.

15 “20. Financial aid to commerce and industry.

16 “21. Public works, bridges, and dams.

17 “(2) There shall also be referred to such committee
18 all proposed legislation, messages, petitions, memorials,
19 and other matters relating to the appropriation, or to the
20 rescission of the appropriation, of revenue for the support
21 of Government programs, projects, or activities relating
22 primarily to the subjects specified in paragraph (d)(1), ex-
23 cept as provided in subparagraph (a).

24 “(e)(1) **Committee on Economic Policy**, to
25 which committee shall be referred all proposed legislation,

1 messages, petitions, memorials, and other matters relating
2 primarily to the following subjects:

3 "1. Bonded debt of the United States, except as pro-
4 vided in the Congressional Budget Act of 1974.

5 "2. Deposits of public moneys.

6 "3. Revenue measures generally, except as provided
7 in the Congressional Budget Act of 1974.

8 "4. Revenue measures relating to the insular pos-
9 sessions.

10 "5. Banks, banking, and financial institutions.

11 "6. Deposit insurance.

12 "7. Federal monetary policy, including the Federal
13 Reserve System.

14 "8. Issuance and redemption of notes.

15 "9. Money and credit, including currency and coin-
16 age.

17 "(2) There shall also be referred to such committee
18 all proposed legislation, messages, petitions, memorials,
19 and other matters relating to the appropriation, or to the
20 rescission of the appropriation, of revenue for the support
21 of Government programs, projects, or activities relating
22 primarily to the subjects specified in paragraph (e)(1), ex-
23 cept as provided in subparagraph (a).

24 "(f)(1) **Committee on Energy Policy**, to which
25 committee shall be referred all proposed legislation, mes-

1 sages, petitions, memorials, and other matters relating
2 primarily to the following subjects:

2 banks, and other international organizations established
3 primarily for development assistance programs.

4 “20. Foreign trade promotion, export, and export
5 controls.

6 “21. Interoceanic canals generally, unless otherwise
7 provided.

8 “22. Customs and ports of entry and delivery.

9 “23. Reciprocal trade agreements.

10 “24. Tariffs and import quotas, and matters related
11 thereto.

12 “25. Organization and management of United States
13 nuclear export policy.

14 “(2) There shall also be referred to such committee
15 all proposed legislation, messages, petitions, memorials,
16 and other matters relating to the appropriation, or to the
17 rescission of the appropriation, of revenue for the support
18 of Government programs, projects, or activities relating
19 primarily to the subjects specified in paragraph (h)(1), ex-
20 cept as provided in subparagraph (a).

21 “(i)(1) **Committee on Governmental Policy**,
22 to which committee shall be referred all proposed legisla-
23 tion, messages, petitions, memorials, and other matters re-
24 lating primarily to the following subjects:

25 “1. Archives of the United States.

1 “2. Budget and accounting measures, except as pro-
2 vided in the Congressional Budget Act of 1974.

3 “3. Census and collection of statistics, including eco-
4 nomic and social statistics.

5 “4. Congressional organizations, except for any part
6 of the matter that amends the rules of order of the Senate.

7 “5. Federal Civil Service.

8 “6. Government information.

9 “7. Intergovernmental relations.

10 “8. Municipal affairs of the District of Columbia.

11 “9. Organization and reorganization of the executive
12 branch of the Government.

13 “10. Postal Service.

14 “11. Status of officers of the United States, including
15 their classification, compensation, and benefits.

16 “12. Renegotiation of governmental contracts.

17 “13. Public buildings and improved grounds of the
18 United States generally, including Federal buildings in the
19 District of Columbia.

20 “(2) There shall also be referred to such committee
21 all proposed legislation, messages, petitions, memorials,
22 and other matters relating to the appropriation, or to the
23 rescission of the appropriation, of revenue for the support
24 of Government programs, projects, or activities relating

1 primarily to the subjects specified in paragraph (i)(1), ex-
2 cept as provided in subparagraph (a).

3 “(j)(1) **Committee on Judicial Policy**, to
4 which committee shall be referred all proposed legislation,
5 messages, petitions, memorials, and other matters relating
6 primarily to the following subjects:

7 “1. Apportionment of Representatives.

8 “2. Bankruptcy, mutiny, espionage, and counterfeit-
9 ing.

10 “3. Civil liberties.

11 “4. Constitutional amendments.

12 “5. Federal courts and judges.

13 “6. Holidays and celebrations.

10 cept as provided in subparagraph (a).

11 “(k)(1) **Committee on Social Policy**, to which
12 committee shall be referred all proposed legislation, mes-
13 sages, petitions, memorials, and other matters relating
14 primarily to the following subjects:

15 “1. Measures relating to education, labor, health, and
16 public welfare.

17 “2. Arts and humanities.

18 “3. Biomedical research and development.

19 “4. Child labor.

20 “5. Domestic activities of the American Red Cross.

21 “6. Equal employment opportunity.

22 “7. Gallaudet College, Howard University, and Saint

23 primarily to the subjects specified in paragraph (n)(1), ex-
24 cept as provided in subparagraph (a).

1 “(o)(1) **Committee on Entrepreneurial**
2 **American Programs**, to which committee shall be re-
3 ferred all proposed legislation, messages, petitions, memo-
4 rials, and other matters relating to the Small Business Ad-
5 ministration.

6 “(2) Any proposed legislation reported by such com-
7 mittee which relates to matters other than the functions
8 of the Small Business Administration shall, at the request
9 of any standing committee having jurisdiction over the
10 subject matter extraneous to the functions of the Small
11 Business Administration, be considered and reported by
12 such standing committee prior to its consideration by the
13 Senate; and likewise measures reported by other commit-
14 tees directly relating to the Small Business Administration
15 shall, at the request of the Committee on Entrepreneurial
16 American Programs for its consideration of any portions
17 of the measure dealing with the Small Business Adminis-
18 tration, be considered and reported by this committee
19 prior to its consideration by the Senate.

20 “(3) There shall also be referred to such committee
21 all proposed legislation, messages, petitions, memorials,
22 and other matters relating to the appropriation, or to the
23 rescission of the appropriation, of revenue for the support
24 of Government programs, projects, or activities relating

1 primarily to the subjects specified in paragraphs (o)(1)
2 and (o)(2), except as provided in subparagraph (a).

3 “(p)(1) **Committee on Senate Rules**, to which
4 committee shall be referred all proposed legislation, mes-
5 sages, petitions, memorials, and other matters relating
6 primarily to the following subjects:

7 “1. Administration of the Senate office buildings and
8 the Senate wing of the Capitol, including the assignment
9 of office space.

10 “2. Congressional organization relative to rules and
11 procedures, and Senate rules and regulations, including
12 floor and gallery rules.

13 “3. Corrupt practices.

14 “4. Credentials and qualifications of members of the
15 Senate, contested elections, and acceptance of incompat-
16 ible offices.

17 “5. Federal elections generally, including the election
18 of the President, Vice President, and members of Con-
19 gress.

20 “6. Government Printing Office, and the printing and
21 correction of the Congressional Record, as well as those
22 matters provided under rule XI.

23 “7. Meetings of the Congress and attendance of the
24 members.

1 “8. Payments of money out of the contingent fund
2 of the Senate or creating a charge upon the same (except
3 that any resolution relating to substantive matter within
4 the jurisdiction of any other standing committee of the
5 Senate shall first be referred to such committee).

6 “9. Presidential succession.

7 “10. Purchase of books and manuscripts and erection
8 of monuments to the memory of individuals.

9 “11. Senate Library and statuary, art, and pictures
10 in the Capitol and Senate office buildings.

11 “12. Services to the Senate, including the Senate
12 restaurant.

13 “13. United States Capitol and congressional office
14 buildings, the Library of Congress, the Smithsonian Insti-
15 tution (and the incorporation of similar institutions), and
16 the Botanic Gardens.

17 “(2) There shall also be referred to such committee
18 all proposed legislation, messages, petitions, memorials,
19 and other matters relating to the appropriation, or to the
20 rescission of the appropriation, of revenue for the support
21 of Government programs, projects, or activities relating
22 primarily to the subjects specified in paragraph (p)(1), ex-
23 cept as provided in subparagraph (a).

24 “2. (a) Except as otherwise provided by paragraph
25 4 of this rule, the Leadership Committee, known as the

1 Committee on National Priorities, shall consist of not less
 2 than 28 Senators nor more than 33 Senators.

3 “(b) Except as otherwise provided by paragraph 4 of
 4 this rule, each of the following standing committees shall
 5 consist of not more than the number of Senators set forth
 6 in the following table on the line on which the name of
 7 that committee appears:

13 “(d) Except as otherwise provided by paragraph 4 of

3 “3. (a) Notwithstanding the provisions of paragraph
 4 4, and except as otherwise provided by this paragraph—

5 “(1) each Senator shall serve on no more than
 6 two committees listed in subparagraph 2(b).

7 “(2) each Senator serving as either a chairman
 8 or a ranking member of any committee listed in sub-
 9 paragraph 2(b) shall serve on the committee listed
 10 in subparagraph 2(a).

11 “(3) each Senator serving as either a chairman
 12 or a ranking member of any committee listed in sub-
 13 paragraph 2(c) shall also serve on the committee
 14 listed in subparagraph 2(a).

15 “(4) in addition to those Senators serving on
 16 the committee listed in subparagraph 2(a) by virtue
 17 of their serving as chairman or ranking member of
 18 a committee listed in subparagraph 2(b), not more
 19 than 5 Senators shall be appointed by the majority
 20 leader of the Senate to serve on the committee listed
 21 in subparagraph 2(a) for the purpose of making the
 22 overall balance of majority and minority members on

1 the committee the same as the relative balance be-
2 tween the majority and minority members of the
3 Senate.

4 “(5) service by a Senator on any committee list-
5 ed in subparagraph 2(c) shall not limit the ability of
6 such Senator to serve on any other committee or
7 standing committee.

8 “(b) By agreement entered into by the majority lead-
9 er and the minority leader, the membership of one or more
10 standing committees may be increased temporarily from
11 time to time by such number or numbers as may be re-
12 quired to accord to the majority party a majority of the
13 membership of all standing committees. Members of the
14 majority party in such numbers as may be required for
15 that purpose may serve as members of three standing
16 committees listed in subparagraph 2(b). No such tem-
17 porary increase in the membership of any Standing com-
18 mittee under this subparagraph shall be continued in ef-
19 fect after the need therefore has ended. No standing com-
20 mittee may be increased in membership under this sub-
21 paragraph by more than two members in excess of the
22 number prescribed for that committee by paragraph 2(b).

23 “(c) No Senator shall serve at any one time as chair-
24 man of more than one subcommittee of each standing
25 committee of the Senate.

1 “4. Notwithstanding any provision of rule XXIV of
2 the Standing Rules of the Senate, the appointment of com-
3 mittees or standing committees as prescribed by this title
4 shall be on the basis of each Senator’s continuous service
5 in the Senate, except that such appointment shall be in
6 accordance with the following limitations:

7 “(a) Only those Senators who on the day preceding
8 the effective date of this title were serving as members
9 of the Committee on Agriculture, Nutrition, and Forestry
10 or who were serving on the Subcommittee on Agriculture,
11 Rural Development, and Related Agencies of the Commit-
12 tee on Appropriations may serve on the Committee on Ag-
13 ricultural Policy.

14 “(b) Only those Senators who on the day preceding
15 the effective date of this title were serving as members
16 of the Committee on Armed Services or who were serving
17 on the Subcommittee on Defense or the Subcommittee on
18 Military Construction of the Committee on Appropriations
19 may serve on the Committee on Defense Policy.

20 “(c) Only those Senators who on the day preceding
21 the effective date of this title were serving as members
22 of the Committee on Commerce, Science, and Transpor-
23 tation or who were serving on the Subcommittee on Trans-
24 portation and Related Agencies of the Committee on Ap-

1 appropriations may serve on the Committee on Commercial
2 Policy.

3 “(d) Only those Senators who on the day preceding
4 the effective date of this title were serving as members
5 of the Committee on Finance or the Committee on Bank-
6 ing, Housing and Urban Affairs may serve on the Com-
7 mittee on Economic Policy.

8 “(e) Only those Senators who on the day preceding
9 the effective date of this title were serving as members
10 of the Committee on Energy and Natural Resources or
11 who were serving on the Subcommittee on Energy and
12 Water Development of the Committee on Appropriations,
13 may serve on the Committee on Energy Policy.

14 “(f) Only those Senators who on the day preceding
15 the effective date of this title were serving as members
16 of the Committee on Environment and Public Works or
17 who were serving on the Subcommittee on Interior and
18 Related Agencies of the Committee on Appropriations may
19 serve on the Committee on Environmental Policy.

20 “(g) Only those Senators who on the day preceding
21 the effective date of this title were serving as members
22 of the Committee on Foreign Relations or who were serv-
23 ing on the Subcommittee on Foreign Operations of the
24 Committee on Appropriations may serve on the Committee
25 on Foreign Policy.

1 “(h) Only those Senators who on the day preceding
2 the effective date of this title were serving as members
3 of the Committee on Governmental Affairs or who were
4 serving on the Subcommittee on Treasury, Postal Service,
5 and General Government or the Subcommittee on the Dis-
6 trict of Columbia or on the Subcommittee on HUD-Inde-
7 pendent Agencies of the Committee on Appropriations
8 may serve on the Committee on Governmental Policy.

9 “(i) Only those Senators who on the day preceding
10 the effective date of this title were serving as members
11 of the Committee on the Judiciary or who were serving
12 on the Subcommittee on Commerce, Justice, State, the
13 Judiciary, and Related Agencies of the Committee on
14 Appropriations may serve on the Committee on Judicial
15 Policy.

16 “(j) Only those Senators who on the day preceding
17 the effective date of this title were serving as members
18 of the Committee on Labor and Human Resources or who
19 were serving on the Subcommittee on Labor, Health and
20 Human Services, Education, and Related Agencies of
21 the Committee on Appropriations, may serve on the
22 Committee on Social Policy.

23 “(k) Only those Senators who on the day preceding
24 the effective date of this title were serving as members
25 of the Committee on Rules and Administration or who

1 were serving on the Subcommittee on Legislative Branch
2 of the Committee on Appropriations may serve on the
3 Committee on Senate Policy.

4 “(l) Only those Senators who on the day preceding
5 the effective date of this title were serving as members
6 of the Select Committee on Indian Affairs may serve on
7 the Committee on Native American Programs.

8 “(m) Only those Senators who on the day preceding
9 the effective date of this title were serving as members
10 of the Committee on Veterans’ Affairs may serve on the
11 Committee on Veteran Programs.

12 “(n) Only those Senators who on the day preceding
13 the effective date of this title were serving as members
14 of the Special Committee on Aging may serve on the Com-
15 mittee on Senior American Programs.

16 “(o) Only those Senators who on the day preceding
17 the effective date of this title were serving as members
18 of the Committee on Small Business may serve on the
19 Committee on Senior American Programs.

20 “5. Upon the effective date of this title, the Select
21 Committee on Ethics shall become the Committee on Sen-
22 ate Ethics, and the Select Committee on Intelligence shall
23 become the Committee on Intelligence Oversight. How-
24 ever, the membership, functions, and duties of such com-
25 mittees shall remain unchanged.”.

1 SEC. 2. Paragraphs 1, 2, 3, 4, 6, and 7 of rule XVI
2 of the Standing Rules of the Senate are repealed, and
3 paragraphs 5 and 8 are renumbered as paragraphs “1”
4 and “2”, respectively.

5 SEC. 3. Subparagraph (b) of paragraph 4 of rule
6 XVII of the Standing Rules of the Senate is amended by
7 striking out “(except the Committee on Appropriations)”.
8 SEC. 4. Rule XXVI of the Standing Rules of the Sen-
9 ate is amended—

10 (a) by striking out “(except the Committee on
11 Appropriations)” in each instance where it appears,

12 (b) by striking out “(except the Committee on
13 Appropriations and the Committee on the Budget)”
14 in each instance where it appears, and inserting in
15 lieu thereof the following “(except the Committee on
16 National Priorities)”,

17 (c) by striking out “The prohibition contained
18 in the preceding sentence shall not apply to the
19 Committee on Appropriations or the Committee on
20 the Budget.” in subparagraph 5(a) and inserting in
21 lieu thereof “The prohibition contained in the pre-
22 ceding sentence shall not apply to the Committee on
23 National Priorities.”,

24 (d) by striking out the last sentence of subpara-
25 graph 10(b), and

3 SEC. 5. The provisions of this resolution shall take
4 effect on the first day of the first Congress following the
5 date of enactment.
