Mr. BOREN submitted the following resolution; which was referred to the  
Committee on Rules and Administration

## RESOLUTION

Authorizing expenditures by the Joint Committee on the  
Organization of Congress

1       *Resolved*, That in carrying out its powers, duties, and  
2 functions under the Standing Rules of the Senate, in ac-  
3 cordance with its jurisdiction under rule XXV of such  
4 rules, including holding hearings, reporting such hearings,  
5 and making investigations as authorized by paragraphs 1  
6 and 8 of rule XXVI of the Standing Rules of the Senate,  
7 the Joint Committee on the Organization of Congress is  
8 authorized \$475,000 from March 1, 1993, to December  
9 31, 1993, in its discretion (1) to make expenditures from  
10 the contingent fund of the Senate, (2) to employ person-

1 nel, and (3) with the prior consent of the Government de-  
2 partment or agency concerned and the Committee on  
3 Rules and Administration, to use on a reimbursable, or  
4 non-reimbursable basis the services of personnel of any  
5 such department or agency.

6 SEC. 2. The expenses of the committee for the period  
7 March 1, 1993, through December 31, 1993, under this  
8 resolution shall not exceed \$475,000, of which not to ex-  
9 ceed \$5,000 may be expended for the training of the pro-  
10 fessional staff of such committee (under procedures speci-  
11 fied by section 202(j) of the Legislative Reorganization  
12 Act of 1946).

13 SEC. 3. The committee shall report its findings, to-  
14 gether with such recommendations for legislation as it  
15 deems advisable, to the Senate at the earliest practicable  
16 date, but not later than December 31, 1993.

17 SEC. 4. Expenses of the committee under this resolu-  
18 tion shall be paid from the contingent fund of the Senate  
19 upon vouchers approved by the chairman of the commit-  
20 tee, except that vouchers shall not be required for (1) the  
21 disbursement of salaries of employees paid at an annual  
22 rate, or (2) the payment of telecommunications provided  
23 by the Office of the Sergeant at Arms and Doorkeeper,  
24 United States Senate, or (3) for the payment of stationery  
25 supplies purchased through the Keeper of Stationery,

1 United States Senate, or (4) for payments to the Post-  
2 master, United States Senate, or (5) for the payment of  
3 metered charges on copying equipment provided by the Of-  
4 fice of the Sergeant at Arms and Doorkeeper, United  
5 States Senate, or (6) for the payment of Senate Recording  
6 and Photographic Services.

7 SEC. 5. There are authorized such sums as may be  
8 necessary for agency contributions related to the com-  
9 pensation of employees of the committee from March 1,  
10 1993, through December 31, 1993, to be paid from the  
11 Appropriations account for “Expenses of Inquiries and In-  
12 vestigations”.
