Mr. LEAHY, from the Committee on Agriculture, Nutrition, and Forestry, reported the following original resolution; which was referred to the Committee on Rules and Administration

---

## RESOLUTION

Authorizing expenditures by the Committee on Agriculture, Nutrition, and Forestry.

1       *Resolved*, That, in carry out its powers, duties, and  
2 functions under the Standing Rules of the Senate, in ac-  
3 cordance with its jurisdiction under rule XXV of such  
4 rules, including holding hearings, reporting such hearings,  
5 and making investigations as authorized by paragraphs 1  
6 and 8 of rule XXVI of the Standing rules of the Senate,  
7 the Committee on Agriculture, Nutrition, and Forestry is  
8 authorized from March 1, 1993, through February 29,  
9 1994, and March 1, 1994, through February 28, 1995,

1 in its discretion (1) to make expenditures from the contin-  
2 gent fund of the Senate, (2) to employ personnel, and (3)  
3 with the prior consent of the Government department or  
4 agency concerned and the Committee on Rules and Ad-  
5 ministration, to use on a reimbursable or non-reimburs-  
6 able basis the services of personnel of any such depart-  
7 ment or agency.

8       SEC. 2. (a) The expenses of the committee for the  
9 period March 1, 1993, through February 29, 1994, under  
10 this resolution shall not exceed \$2,027,632 of which  
11 amount (1) not to exceed \$4,000 may be expended for the  
12 procurement of the services of individual consultants, or  
13 organizations thereof (as authorized by section 202(i) of  
14 the Legislative Reorganization Act of 1946, as amended),  
15 and not to exceed \$4,000 may be expended for the training  
16 of the professional staff of such committee (under proce-  
17 dures specified by section 202(j) of the Legislative Reorga-  
18 nization Act of 1946).

19       (b) For the period March 1, 1994, through February  
20 28, 1995, expenses of the committee under this resolution  
21 shall not exceed \$1,973,136 of which amount (1) not to  
22 exceed \$4,000 may be expended for the procurement of  
23 the services of individual consultants, or organizations  
24 thereof (as authorized by section 202(i) of the Legislative  
25 Reorganization Act of 1946, as amended), and not to ex-

1 ceed \$4,000 may be expended for the training of the pro-  
2 fessional staff or such committee (under procedures speci-  
3 fied by section 202(j) of the Legislative Reorganization  
4 Act of 1946).

5 SEC. 3. The committee shall report its findings, to-  
6 gether with such recommendations for legislation as it  
7 deems advisable, to the Senate at the earliest practicable  
8 date, but not later than February 28, 1994, and February  
9 28, 1995, respectively.

10 SEC. 4. Expenses of the committee under this resolu-  
11 tion shall be paid from the contingent fund of the Senate  
12 upon vouchers approved by the chairman of the commit-  
13 tee, except that vouchers shall not be required (1) for the  
14 disbursement of salaries of employees paid at an annual  
15 rate, or (2) the payment of telecommunications provided  
16 by the Office of the Sergeant at Arms and Doorkeeper,  
17 United States Senate, or (3) for the payment of stationery  
18 supplies purchased through the Keeper of Stationery,  
19 United States Senate, or (4) for payments to the Post-  
20 master, United States Senate, or (5) for the payment of  
21 metered charges on copying equipment provided by the Of-  
22 fice of the Sergeant at Arms and Doorkeeping, United  
23 States Senate, or (6) for the payment of Senate Recording  
24 and Photographic Services.

1        SEC. 5. There are authorized such sums as may be  
2 necessary for agency contributions related to the com-  
3 pensation of employees of the committee from March 1,  
4 1993, through February 28, 1994, and March 1, 1994,  
5 through February 28, 1995, to be paid from the Appro-  
6 priations account for “Expenses of Inquiries and Inves-  
7 tigations.”.
