Authorizing expenditures by the Committee on Banking, Housing, and Urban Affairs.

IN THE SENATE OF THE UNITED STATES

FEBRUARY 2 (legislative day, JANUARY 5), 1993

Mr. RIEGLE, from the Committee on Banking, Housing, and Urban Affairs, reported the following original resolution; which was referred to the Committee on Rules and Administration

RESOLUTION

Authorizing expenditures by the Committee on Banking,
Housing, and Urban Affairs.

1 *Resolved*, That, in carrying out its powers, duties, and
2 functions under the Standing Rules of the Senate, in ac-
3 cordance with its jurisdiction under rule XXV of such
4 rules, including holding hearings, reporting such hearings,
5 and making investigations as authorized by paragraphs 1
6 and 8 of rule XXVI of the Standing Rules of the Senate,
7 the Committee on Banking, Housing, and Urban Affairs
8 is authorized from March 1, 1993, through February 29,
9 1994, and March 1, 1994, through February 28, 1995,
10 in its discretion (1) to make expenditures from the contin-

1 gent fund of the Senate, (2) to employ personnel, and (3)
2 with the prior consent of the Government department or
3 agency concerned and the Committee on Rules and Ad-
4 ministration, to use on a reimbursable, or
5 nonreimbursable, basis the services of personnel of any
6 such department or agency.

7 SEC. 2. (a) The expenses of the committee for the
8 period March 1, 1993, through February 29, 1994, under
9 this resolution shall not exceed \$3,386,083, of which
10 amount not to exceed \$1,000 may be expended for the pro-
11 curement of the services of individual consultants, or orga-
12 nizations thereof (as authorized by section 202(i) of the
13 Legislative Reorganization Act of 1946, as amended), and
14 not to exceed \$1,000 may be expended for the training
15 of the professional staff of such committee (under proce-
16 dures specified by section 202(j) of the Legislative Reorga-
17 nization Act of 1946).

18 (b) For the period March 1, 1994, through February
19 28, 1995, expenses of the committee under this resolution
20 shall not exceed \$3,458,110, of which amount not to ex-
21 ceed \$1,000 may be expended for the procurement of the
22 services of individual consultants, or organizations thereof
23 (as authorized by section 202(i) of the Legislative Reorga-
24 nization Act of 1946, as amended), and not to exceed
25 \$1,000 may be expended for the training of the profes-

1 sional staff of such committee (under procedures specified
2 by section 202(j) of the Legislative Reorganization Act of
3 1946).

4 SEC. 3. The committee shall report its findings, to-
5 gether with such recommendations for legislation as it
6 deems advisable, to the Senate at the earliest practicable
7 date, but not later than February 29, 1994, and February
8 28, 1995, respectively.

9 SEC. 4. Expenses of the committee under this resolu-
10 tion shall be paid from the contingent fund of the Senate
11 upon vouchers approved by the chairman of the commit-
12 tee, except that vouchers shall not be required for the dis-
13 bursement of salaries of employees paid at an annual rate,
14 the payment of long distance telephone calls, or for the
15 payment of stationery supplies purchased through the
16 Keeper of Stationery, United States Senate.

17 SEC. 5. There are authorized such sums as may be
18 necessary for agency contributions related to the com-
19 pensation of employees of the committee from March 1,
20 1993, through February 29, 1994, and March 1, 1994,
21 through February 28, 1995, to be paid from the
22 Appropriations account for "Expenses of Inquiries and
23 Investigations".
