Authorizing expenditures by the Committee on Small Business.

IN THE SENATE OF THE UNITED STATES

FEBRUARY 2 (legislative day, JANUARY 5), 1993

Mr. BUMPERS, from the Committee on Small Business, reported the following original resolution; which was referred to the Committee on Rules and Administration

RESOLUTION

Authorizing expenditures by the Committee on Small
Business.

1 *Resolved*, That, in carrying out its powers, duties, and
2 functions under the Standing Rules of the Senate, in ac-
3 cordance with its jurisdiction under rule XXV of such
4 rules, including holding hearings, reporting such hearings,
5 and making investigations as authorized by paragraphs 1
6 and 8 of rule XXVI of the Standing Rules of the Senate,
7 the Committee on Small Business is authorized from
8 March 1, 1993, through February 28, 1994, and March
9 1, 1994, through February 28, 1995, in its discretion (1)
10 to make expenditures from the contingent fund of the Sen-

1 ate, (2) to employ personnel, and (3) with the prior con-
2 sent of the Government department or agency concerned
3 and the Committee on Rules and Administration, to use
4 on a reimbursable or nonreimbursable basis the services
5 of personnel of any such department or agency.

6 SEC. 2 (a) The expenses of the committee for the pe-
7 riod March 1, 1993, through February 28, 1994, under
8 this resolution shall not exceed \$1,137,330, of which
9 amount (1) not to exceed \$10,000 may be expended for
10 the procurement of the services of individual consultants,
11 or organizations thereof (as authorized by section 202(i)
12 of the Legislative Reorganization Act of 1946, as amend-
13 ed), and (2) not to exceed \$2,000 may be expended for
14 the training of the professional staff of such committee
15 (under procedures specified by section 202(j) of the Legis-
16 lative Reorganization Act of 1946).

17 (b) For the period March 1, 1994, through February
18 28, 1995, expenses of the committee under this resolution
19 shall not exceed \$1,161,856, of which (1) not to exceed
20 \$10,000 may be expended for the procurement of the serv-
21 ices of individual consultants, or organizations thereof (as
22 authorized by section 202(i) of the Legislative Reorganiza-
23 tion Act of 1946, as amended), and (2) not to exceed
24 \$2,000 may be expended for the training of the profes-
25 sional staff of such committee (under procedures specified

1 by section 202(j) of the Legislative Reorganization Act of
2 1946).

3 SEC. 3. The committee shall report its findings, to-
4 gether with such recommendations for legislation as it
5 deems advisable, to the Senate at the earliest practicable
6 date, but not later than February 28, 1994, and February
7 28, 1995, respectively.

8 SEC. 4. Expenses of the committee under this resolu-
9 tion shall be paid from the contingent fund of the Senate
10 upon vouchers approved by the chairman of the commit-
11 tee, except that vouchers shall not be required (1) for the
12 disbursement of salaries of employees paid at an annual
13 rate, or (2) for the payment of telecommunications pro-
14 vided by the Office of the Sergeant at Arms and Door-
15 keeper, United States Senate, or (3) for the payment of
16 stationery supplies purchased through the Keeper of the
17 Stationery, United States Senate, or (4) for payments to
18 the Postmaster, United States Senate, or (5) for the pay-
19 ment of metered charges on copying equipment provided
20 by the office of the Sergeant at Arms and Doorkeeper,
21 United States Senate, or (6) for the payment of Senate
22 Recording and Photographic Services.

23 SEC. 5. There are authorized such sums as may be
24 necessary for agency contributions related to the com-
25 pensation of employees of the committee from March 1,

1 1993, through February 28, 1994, and March 1, 1994,
2 through February 28, 1995, to be paid from the Appro-
3 priations account for “Expenses of Inquiries and Inves-
4 tigations”.
