A BILL

To reduce the Official Mail Allowance of Members of the House and to prohibit certain other mailing practices, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-
2 tives of the United States of America in Congress assembled,*

3 **SECTION 1. REDUCTION IN OFFICIAL MAIL ALLOWANCE.**

4 Section 311(e)(2)(B)(i) of the Legislative Branch Ap-
5 propriations Act, 1991 (2 U.S.C. 59e(e)(2)(B)(i)) is
6 amended by striking “3 times” and inserting “1.5 times”.

1 **SEC. 2. BAN ON TRANSFER FROM OFFICIAL EXPENSES AL-**
2 **LOWANCE AND CLERK HIRE ALLOWANCE TO**
3 **OFFICIAL MAIL ALLOWANCE.**

4 Section 311(e) of the Legislative Branch Appropria-
5 tions Act, 1991 (2 U.S.C. 59e(e)) is amended by striking
6 paragraph (3).

7 **SEC. 3. BAN ON UNSOLICITED MAIL AS FRANKED MAIL**
8 **WITHIN 60 DAYS BEFORE A MEMBER'S PRI-**
9 **MARY AND GENERAL ELECTION.**

10 Section 3210(a)(6) of title 39, United States Code,
11 is amended—

12 (1) by striking “mass mailing” and inserting
13 “unsolicited mailing” each place it occurs in sub-
14 paragraphs (A) through (D); and

15 (2) by adding at the end the following:

16 “(G) As used in this paragraph, the term
17 ‘unsolicited mailing’ means all mail other than
18 mail that is—

19 “(i) in direct response to a commu-
20 nication from a person to whom the matter
21 is mailed;

22 “(ii) from a Member of Congress to
23 other Members of Congress;

24 “(iii) of a news release to the commu-
25 nlications media; or

1 “(iv) in furtherance of the administra-
2 tive duties of the Member of Congress.”.

3 **SEC. 4. DISCLOSURE OF MEMBER'S FIRST CLASS MAILINGS**

4 **TO THE PUBLIC.**

5 Section 311(a)(3) of the Legislative Branch Appro-
6 priations Act, 1991 (2 U.S.C. 59e(a)(3)) is amended by
7 adding before the period at the end “, including (by sepa-
8 rate category) the costs relating to franked, first class
9 mass mailings”.

10 **SEC. 5. EFFECTIVE DATE.**

11 The amendments made by this section shall apply
12 with respect to sessions of Congress beginning after the
13 date of enactment of this Act.
