A BILL

To suspend temporarily the duty on certain chemicals used
in the formulation of an HIV Protease Inhibitor.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 SECTION 1. TEMPORARY DUTY SUSPENSION.

4 (a) IN GENERAL.—Subchapter II of chapter 99 of
5 the Harmonized Tariff Schedule of the United States is
6 amended by inserting in numerical sequence the following
7 new headings:

1 (b) EFFECTIVE DATE.—

2 (1) IN GENERAL.—The amendment made by
3 subsection (a) applies with respect to goods entered,
4 or withdrawn from warehouse for consumption, on
5 or after the date that is 15 days after the date of
6 the enactment of this Act.

7 (2) RETROACTIVE APPLICATION.—Notwith-
8 standing section 514 of the Tariff Act of 1930 (19
9 U.S.C. 1514) or any other provision of law, upon
10 proper request filed with the Customs Service, before
11 the 90th day after the date of the enactment of this
12 Act, any entry, or withdrawal from warehouse for
13 consumption, of an article described in heading
14 9902.30.63, 9902.30.64, or 9902.30.65 of the Har-
15 monized Tariff Schedule of the United States (as
16 added by subsection (a)), that was made—

17 (A) on or after August 1, 1996, and

18 (B) before the date that is 15 days after
19 the date of the enactment of this Act,

1 shall be liquidated or reliquidated as though such
2 entry or withdrawal was made on the 15th day after
3 such date of enactment.
