1 *Resolved by the House of Representatives (the Senate*
2 *concurring)*, That, in the enrollment of the bill H.R. 2400
3 the Clerk of the House of Representatives shall make the

13 (F) in item 702, relating to I-4 in Or-
 14 lando, Florida, by striking “10.5” and insert
 15 “10.0”;

16 (G) in item 770, relating to US-17/92 in
 17 Volusia County, Florida, striking “1.35” and
 18 insert “1.0”

19 (H) in item 789, relating to construction
 20 of interchange, Orange County, Florida, strike
 21 “2.0625” and insert “1.0”;

1 (I) in item 635, relating to Florida Na-
 2 tional Scenic Trail, strike “1.875” and insert
 3 “2.15”; and

4 (J) in item 1383, relating to improvements
 5 to Alden Road, Florida, strike “0.525” and in-
 6 sert “0.35”; and

7 (2) in section 1212 by striking subsection (v)
 8 and inserting the following:

9 “(v) BOUNDARY WATERS CANOE AREA.—Effective
 10 January 1, 1999, section 4 of the Act of October 21, 1978
 11 (Public Law 95–495) is amended—

12 “(1) by striking subsection (g) and inserting
 13 the following:

14 ‘(g) Nothing in this Act shall be construed to prevent
 15 the operation of motorized vehicles to transport boats
 16 across the portages between the Moose Lake Chain and
 17 Basswood Lake, Minnesota, and between Vermilion Lake
 18 and Trout Lake, Minnesota.’; and

19 “(2) in subsection (c)(2) by striking ‘; Alder,
 20 Cook County; Canoe, Cook County’ ”.

21 (3) On page 1A–71, line 22, insert after system
 22 “\$10,000,000 of such amounts shall be available to
 23 the state of Alabama for fiscal years 1999 and
 24 2000”; and

1 (4) On page 1B–129, after line 10, insert the
2 following new subsections and redesignate succeed-
3 ing subsections accordingly:

4 “(g)(1) The Secretary shall provide \$10 million for
5 construction of Highway 323 between Alzada and the vi-
6 cinity of Ekalaka, Montana.

7 “(2) Funds made available for delegation in the same
8 manner as if funds had been apportioned under chapter
9 1 of title 23, United States Code.

10 “(h)(1) The Secretary shall provide \$1.125 million
11 for construction of Third Street North, CSAH 81, Waite
12 Park.

13 “(2) Funds made available for delegation in the same
14 manner as if funds had been apportioned under chapter
15 1 of title 23, United States Code.”.
