CONCURRENT RESOLUTION

Expressing the sense of the Congress that a commemorative postage stamp should be issued honoring Paul Leroy Robeson, and that the Citizens' Stamp Advisory Committee should recommend to the Postmaster General in 1999, that such a stamp be issued.

- 1 Whereas April 9, 1998, was the centennial of the birth
- 2 of Paul Leroy Robeson;
- 3 Whereas Paul Leroy Robeson lost his mother, Anna, in
- 4 a household fire, and was reared in humble cir-
- 5 cumstances as 1 of 5 children in a single-parent

1 household by his father, William Drew Robeson, a
 2 Presbyterian minister, who graduated from Lincoln
 3 University;

4 Whereas despite difficult circumstances, as a child, Paul
 5 Leroy Robeson showed significant promise as an
 6 honor student, thespian, and athlete;

7 Whereas Paul Leroy Robeson graduated from Rutgers
 8 University in 1919, with letters in basketball, base-
 9 ball, discus, shot put, football, and javelin, and, more
 10 importantly, was a member of both the Phi Beta
 11 Kappa and Cap and Skull honor societies at Rutgers
 12 University;

13 Whereas Paul Leroy Robeson graduated from Columbia
 14 Law School in 1923, but found the legal profession
 15 so resistant to African-American lawyers that he em-
 16 barked on a career in the theater and arts which
 17 brought him world renown; and

18 Whereas Paul Leroy Robeson became an advocate for the
 19 rights of African-Americans and other oppressed peo-
 20 ple, and in so doing sacrificed his career as a world-
 21 renowned actor and singer: Now, therefore, be it

22 *Resolved by the House of Representatives (the Senate*
 23 *concurring)*, That it is the sense of the Congress that—

1 (1) a commemorative postage stamp should be
2 issued by the United States Postal Service honoring
3 Paul Leroy Robeson; and

4 (2) the Citizens' Stamp Advisory Committee
5 should recommend to the Postmaster General that
6 such a stamp be issued.
