Mr. WARNER introduced the following bill; which was read twice and referred to the Committee on Armed Services

A BILL

To amend title 10, United States Code, to extend to persons over age 64 eligibility for medical care under CHAMPUS and TRICARE; to extend the TRICARE Senior Prime demonstration program in conjunction with the extension of eligibility under CHAMPUS and TRICARE to such persons, and for other purposes.

1 **SECTION 1. CONDITIONS FOR ELIGIBILITY FOR CHAMPUS**2 **UPON THE ATTAINMENT OF 65 YEARS OF**
3 **AGE.**4 (a) ELIGIBILITY OF MEDICARE ELIGIBLE PER-
5 SONS.—Section 1086(d) of title 10, United States Code,
6 is amended—7 (1) by striking paragraph (2) and inserting the
8 following:9 “(2) The prohibition contained in paragraph (1) shall
10 not apply to a person referred to in subsection (c) who—11 “(A) is enrolled in the supplementary medical
12 insurance program under part B of such title (42
13 U.S.C. 1395j et seq.); and14 “(B) in the case of a person under 65 years of
15 age, is entitled to hospital insurance benefits under
16 part A of title XVIII of the Social Security Act pur-
17 suant to subparagraph (A) or (C) of section
18 226(b)(2) of such Act (42 U.S.C. 426(b)(2)) or sec-
19 tion 226A(a) of such Act (42 U.S.C. 426–1(a)).”;
20 and21 (2) in paragraph (4), by striking “paragraph
22 (1) who satisfy only the criteria specified in subpara-
23 graphs (A) and (B) of paragraph (2), but not sub-
24 paragraph (C) of such paragraph,” and inserting
25 “subparagraph (B) of paragraph (2) who do not sat-

1 isfy the condition specified in subparagraph (A) of
2 such paragraph".

3 (b) EXTENSION OF TRICARE SENIOR PRIME DEM-
4 ONSTRATION PROGRAM.—Paragraph (4) of section
5 1896(b) of the Social Security Act (42 U.S.C.
6 1395ggg(b)) is amended by striking "3-year period begin-
7 ning on January 1, 1998" and inserting "period beginning
8 on January 1, 1998, and ending on December 31, 2002".

9 (c) REPEAL OF RELATED DEMONSTRATION PRO-
10 GRAM.—Section 702 of the National Defense Authoriza-
11 tion Act for Fiscal Year 1993 (Public Law 102-484; 106
12 Stat. 2431; 10 U.S.C. 1079 note) is repealed.

13 (d) EFFECTIVE DATES.—(1) Except as provided in
14 paragraph (2), the amendments made by this section shall
15 take effect on October 1, 2001.

16 (2) The amendment made by subsection (b) shall take
17 effect on the date of the enactment of this Act.
