A BILL

To repeal the provisions of law that provide automatic pay adjustments for Members of Congress, the Vice President, certain senior executive officers, and Federal judges, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. ELIMINATION OF AUTOMATIC PAY ADJUST-**
4 **MENTS FOR FEDERAL OFFICIALS.**

5 (a) MEMBERS OF CONGRESS.—

6 (1) IN GENERAL.—Paragraph (2) of section
7 601(a) of the Legislative Reorganization Act of
8 1946 (2 U.S.C. 31) is repealed.

1 (2) TECHNICAL AND CONFORMING AMEND-
 2 MENTS.—Section 601(a)(1) of such Act is
 3 amended—

4 (A) by striking “(a)(1)” and inserting
 5 “(a)”;

6 (B) by redesignating subparagraphs (A),
 7 (B), and (C) as paragraphs (1), (2), and (3),
 8 respectively; and

9 (C) by striking “as adjusted by paragraph
 10 (2) of this subsection” and inserting “adjusted
 11 as provided by law”.

12 (b) VICE PRESIDENT.—Section 104 of title 3, United
 13 States Code, is amended—

14 (1) in subsection (a)—

15 (A) by striking “(a)”;

16 (B) in the first sentence by striking “as
 17 adjusted under this section” and inserting “ad-
 18 justed as provided by law”; and

19 (C) by striking the second and third sen-
 20 tences; and

21 (2) by striking subsection (b).

22 (c) EXECUTIVE SCHEDULE POSITIONS.—

23 (1) IN GENERAL.—Section 5318 of title 5,
 24 United States Code, is repealed.

1 (2) TECHNICAL AND CONFORMING AMEND-
2 MENTS.—

3 (A) The table of sections for chapter 53 of
4 title 5, United States Code, is amended by
5 striking the item relating to section 5318.

6 (B) Sections 5312, 5313, 5314, 5315, and
7 5316 of title 5, United States Code, are each
8 amended by striking “as adjusted by section
9 5318 of this title” and inserting “adjusted as
10 provided by law”.

11 (d) JUSTICES AND JUDGES.—

12 (1) IN GENERAL.—Section 461 of title 28,
13 United States Code, is repealed.

14 (2) TECHNICAL AND CONFORMING AMEND-
15 MENTS.—

16 (A) The table of sections for chapter 21 of
17 title 28, United States Code, is amended by
18 striking the item relating to section 461.

19 (B) Sections 5, 44(d), 135, and 252 of
20 title 28, United States Code, are each amended
21 by striking “as adjusted by section 461 of this
22 title” and inserting “adjusted as provided by
23 law”.

24 (C) Section 371(b)(2) of title 28, United
25 States Code, is amended in the second sentence

1 by striking “under section 461 of this title” and
2 inserting “as provided by law”.

3 (e) EFFECTIVE DATES.—This section shall take ef-
4 fect on February 1, 2001.
