Mr. HARKIN (for himself, Mr. LEAHY, Mr. WELLSTONE, Mr. HOLLINGS, Mr. FEINGOLD, Mr. LAUTENBERG, and Mr. SCHUMER) introduced the following bill; which was read twice and referred to the Committee on Finance

A BILL

To prohibit the importation of any textile or apparel article that is produced, manufactured, or grown in Burma.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SANCTIONS AGAINST BURMA.**

4 (a) IMPOSITION OF SANCTIONS.—

5 (1) IN GENERAL.—Notwithstanding any other
6 provision of law, until such time as the President de-
7 termines and certifies to Congress that Burma has
8 met the conditions described in paragraph (2), no
9 textile or apparel article that is—

1 (A) described in chapter 50, 51, 52, 53,
 2 54, 55, 56, 57, 58, 59, 60, 61, 62, or 63 of the
 3 Harmonized Tariff Schedule of the United
 4 States, and

5 (B) is produced, manufactured, or grown
 6 in Burma,
 7 may be imported into the United States.

8 (2) CONDITIONS DESCRIBED.—The conditions
 9 described in this paragraph are the following:

10 (A) The Government of Burma has made
 11 substantial progress in reversing the persistent
 12 pattern of gross violations of internationally-
 13 recognized human rights and worker rights, in-
 14 cluding the elimination of forced labor and the
 15 worst forms of child labor.

16 (B) The Government of Burma has made
 17 measurable and substantial progress toward im-
 18 plementing democratic government including—

- 19 (i) releasing all political prisoners;
- 20 (ii) developing a dialogue between the
 21 State Peace and Development Council
 22 (SPDC) and democratic opposition groups
 23 within Burma (including Aung San Suu
 24 Kyi and the National League for Democ-

1 racy (NLD) and leaders of Burma's ethnic
2 groups); and

3 (iii) holding free and fair elections as
4 called for by those officials who were duly
5 elected in Burma in 1990.

6 (C) The Government of Burma has made
7 measurable and substantial progress toward full
8 cooperation with United States counter-nar-
9 cotics efforts pursuant to the terms of section
10 570(a)(1)(B) of Public Law 104–208, the For-
11 eign Operations, Export Financing, and Related
12 Programs Appropriations Act, 1997.

13 (b) EFFECTIVE DATE.—The provisions of this sec-
14 tion shall apply to any article entered, or withdrawn from
15 warehouse for consumption, on or after the 15th day after
16 the date of enactment of this Act.
