A BILL

To require the Office of Personnel Management to conduct a study to determine the approximate number of Federal employees and annuitants who are eligible to participate in the health benefits program under chapter 89 of title 5, United States Code, but who are covered neither by such program nor by any other health insurance, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. STUDY AND REPORT.**

2 (a) IN GENERAL.—Within 9 months after the date
3 of the enactment of this Act, the Office of Personnel Man-
4 agement shall conduct a study to determine, and shall sub-
5 mit a written report to Congress containing its findings
6 concerning—

7 (1) the approximate total number of Federal
8 employees and the approximate total number of Fed-
9 eral annuitants who—

10 (A) are eligible to participate in the health
11 benefits program under chapter 89 of title 5,
12 United States Code; but

13 (B) are covered neither by such program
14 nor by any other health insurance;

15 (2) the principal reasons why those individuals
16 did not obtain health insurance under such chapter
17 89;

18 (3) out of each of the total numbers referred to
19 in paragraph (1), the approximate number (and per-
20 centage) assignable to each of the reasons identified
21 under paragraph (2);

22 (4) out of the total number of Federal employ-
23 ees referred to in paragraph (1), the approximate
24 number (and percentage)—

1 (A) employed in the respective depart-
2 ments, agencies, or other instrumentalities of
3 the Government; and

4 (B) paid at the respective grades, levels, or
5 rates of pay applicable to Federal employees;
6 and

7 (5) with respect to the Federal annuitants re-
8 ferred to in paragraph (1), such further details or
9 characteristics of the group as the Office considers
10 relevant.

11 (b) FORMAT.—The findings contained in the Office’s
12 report under this section shall be presented both in the
13 aggregate and by State.

14 (c) ADDITIONAL MATTERS.—The report may include
15 such additional matters (including any recommendations
16 for legislation) as the Office considers appropriate.

17 (d) DEFINITIONS.—For purposes of this section—

18 (1) the terms “Federal employees” and “Fed-
19 eral annuitants” refer to employees and annuitants,
20 respectively, within the meaning of section 8901 of
21 title 5, United States Code; and

22 (2) the term “State” includes the District of
23 Columbia.
