Mr. HASTINGS of Florida introduced the following bill; which was referred to the Committee on Government Reform

A BILL

To establish the National Office for Combatting Terrorism.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 **SECTION 1. NATIONAL OFFICE FOR COMBATTING TER-**
4 **RORISM.**

5 (a) ESTABLISHMENT.—There is established within
6 the Executive Office of the President an office to be known
7 as the “National Office for Combatting Terrorism” (in
8 this section referred to as the “Office”).

9 (b) OFFICERS.—(1) The head of the Office shall be
10 the Director of the National Office for Combatting Ter-
11 rorism, who shall be appointed by the President, by and
12 with the advice and consent of the Senate.

1 (2) The President shall assign to the Office such
2 other officers, if any, as the President, in consultation
3 with the Director, considers appropriate to discharge the
4 responsibilities of the Office.

5 (c) RESPONSIBILITIES.—Subject to the direction and
6 control of the President, the responsibilities of the Office
7 shall include the following:

8 (1) To develop policies, goals, objectives, and
9 priorities for the United States for the prevention of
10 and response to terrorism.

11 (2) To develop a comprehensive strategy for the
12 United States for the prevention of and response to
13 terrorism to be known as the “National Terrorism
14 Prevention and Response Strategy” (in this section
15 referred to as the “Strategy”).

16 (3) To coordinate, oversee, and evaluate the im-
17 plementation and execution of the Strategy by the
18 agencies of the Federal Government with respon-
19 sibilities for terrorism prevention and response
20 under the Strategy.

21 (4) To coordinate and oversee the programs
22 and activities of State and local governments as part
23 of the Strategy, including ensuring that mechanisms
24 exist for communication and coordination in the
25 event of a terrorist attack.

20 (d) RESOURCES.—The President shall, in consulta-
21 tion with the Director, assign or allocate to the Office such
22 resources, including funds, personnel, and other resources,
23 as the President considers appropriate in order to facili-
24 tate the discharge of the responsibilities of the Office.

1 (e) OVERSIGHT BY CONGRESS.—The location of the
2 Office in the Executive Office of the President shall not
3 be construed as affecting access by Congress, or any com-
4 mittee of Congress, to—

5 (1) any information, document, record, or paper
6 in the possession of the Office or any study con-
7 ducted by or at the direction of the Director; or
8 (2) any personnel of the Office.

9 (f) PAY OF DIRECTOR.—Section 5312 of title 5,
10 United States Code, is amended by inserting after the
11 item relating to the Director of National Drug Control
12 Policy the following new item:

13 “Director of the National Office for Combatting
14 Terrorism.”.
