Mr. JOHNSON (for himself, Mr. GRASSLEY, Mr. THOMAS, and Mr. DASCHLE) introduced the following bill; which was read twice and referred to the Committee on Agriculture, Nutrition, and Forestry

A BILL

To amend the Packers and Stockyards Act, 1921, to make it unlawful for a packer to own, feed, or control livestock intended for slaughter.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PROHIBITION ON PACKERS OWNING, FEEDING,**
4 **OR CONTROLLING LIVESTOCK.**

5 (a) IN GENERAL.—Section 202 of the Packers and
6 Stockyards Act, 1921 (7 U.S.C. 192), is amended—

7 (1) by redesignating subsections (f) and (g) as
8 subsections (g) and (h), respectively;

1 (2) by inserting after subsection (e) the fol-
 2 lowing:

3 “(f) Own, feed, or control livestock intended for
 4 slaughter (for more than 14 days prior to slaughter and
 5 acting through the packer or a person that directly or indi-
 6 rectly controls, or is controlled by or under common con-
 7 trol with, the packer), except that this subsection shall not
 8 apply to—

9 “(1) a cooperative, if a majority of the owner-
 10 ship interest in the cooperative is held by active co-
 11 operative members that—

12 “(A) own, feed, or control livestock; and

13 “(B) provide the livestock to the coopera-
 14 tive for slaughter; or

15 “(2) a packer that is owned or controlled by
 16 producers of a type of livestock, if during a calendar
 17 year the packer slaughters less than 2 percent of the
 18 head of that type of livestock slaughtered in the
 19 United States; or”; and

20 (3) in subsection (h) (as so redesignated), by
 21 striking “or (e)” and inserting “(e), or (f)”.

22 (b) EFFECTIVE DATE.—

23 (1) IN GENERAL.—Subject to paragraph (2),
 24 the amendments made by subsection (a) take effect
 25 on the date of enactment of this Act.

1 (2) TRANSITION RULES.—In the case of a pack-
2 er that on the date of enactment of this Act owns,
3 feeds, or controls livestock intended for slaughter in
4 violation of section 202(f) of the Packers and Stock-
5 yards Act, 1921 (as amended by subsection (a)), the
6 amendments made by subsection (a) apply to the
7 packer—

8 (A) in the case of a packer of swine, begin-
9 ning on the date that is 18 months after the
10 date of enactment of this Act; and

11 (B) in the case of a packer of any other
12 type of livestock, beginning as soon as prac-
13 ticable, but not later than 180 days, after the
14 date of enactment of this Act, as determined by
15 the Secretary of Agriculture.
