Authorizing expenditures by the Committee on Banking, Housing, and Urban Affairs.

IN THE SENATE OF THE UNITED STATES

Mr. GRAMM, from the Committee on Banking, Housing, and Urban Affairs, reported the following original resolution; which was referred to the Committee on Rules and Administration

RESOLUTION

Authorizing expenditures by the Committee on Banking,
Housing, and Urban Affairs.

1 *Resolved*, That, in carrying out its powers, duties, and
2 functions under the Standing Rules of the Senate, in ac-
3 cordance with its jurisdiction under rule XXV of such
4 rules, including holding hearings, reporting such hearings,
5 and making investigations as authorized by paragraphs 1
6 and 8 of rule XXVI of the Standing Rules of the Senate,
7 the Committee on Banking, Housing, and Urban Affairs
8 is authorized from March 1, 2001, through September 30,
9 2001; October 1, 2001, through September 30, 2002; and
10 October 1, 2002, through February 28, 2003, in its discre-

1 tion (1) to make expenditures from the contingent fund
2 of the Senate, (2) to employ personnel, and (3) with the
3 prior consent of the Government department or agency
4 concerned and the Committee on Rules and Administra-
5 tion, to use on a reimbursable or non-reimbursable basis
6 the services of personnel of any such department or
7 agency.

8 SEC. 2. (a) The expenses of the committee for the
9 period March 1, 2001, through September 30, 2001,
10 under this resolution shall not exceed \$2,741,526 of which
11 amount (1) not to exceed \$11,667 may be expended for
12 the procurement of the services of individual consultants,
13 or organizations thereof (as authorized by section 202(i)
14 of the Legislative Reorganization Act of 1946, as amend-
15 ed), and (2) not to exceed \$496 may be expended for the
16 training of the professional staff of such committee (under
17 procedures specified by section 202(j) of the Legislative
18 Reorganization Act of 1946).

19 (b) For the period of October 1, 2001, through Sep-
20 tember 30, 2002, expenses of the committee under this
21 resolution shall not exceed \$4,862,013 of which amount
22 (1) not to exceed \$20,000 may be expended for the pro-
23 curement of the services of individual consultants, or orga-
24 nizations thereof (as authorized by section 202(i) of the
25 Legislative Reorganization Act of 1946, as amended), and

1 (2) not to exceed \$850 may be expended for the training
2 of the professional staff of such committee (under proce-
3 dures specified by section 202(j) of the Legislative Reorga-
4 nization Act of 1946).

5 (c) For the period of October 1, 2002, through Feb-
6 ruary 28, 2003, expenses of the committee under this res-
7 olution shall not exceed \$2,079,076 of which amount (1)
8 not to exceed \$8,333 may be expended for the procure-
9 ment of the services of individual consultants, or organiza-
10 tions thereof (as authorized by section 202(i) of the Legis-
11 lative Reorganization Act of 1946, as amended), and (2)
12 not to exceed \$354 may be expended for the training of
13 the professional staff of such committee (under procedures
14 specified by section 202(j) of the Legislative Reorganiza-
15 tion Act of 1946).

16 SEC. 3. The committee shall report its findings, to-
17 gether with such recommendations for legislation as it
18 deems advisable, to the Senate at the earliest practicable
19 date, but not later than February 28, 2003.

20 SEC. 4. Expenses of the committee under this resolu-
21 tion shall be paid from the contingent fund of the Senate
22 upon vouchers approved by the chairman of the com-
23 mittee, except that vouchers shall not be required (1) for
24 the disbursement of salaries of employees paid at an an-
25 nual rate, or (2) for the payment of telecommunications

1 provided by the Office of the Sergeant at Arms and Door-
2 keeper, United States Senate, or (3) for the payment of
3 stationery supplies purchased through the Keeper of the
4 Stationery, United States Senate, or (4) for payments to
5 the Postmaster, United States Senate, or (5) for the pay-
6 ment of metered charges on copying equipment provided
7 by the Office of the Sergeant at Arms and Doorkeeper,
8 United States Senate, or (6) for the payment of Senate
9 Recording and Photographic Services, or (7) for payment
10 of franked and mass mail costs by the Sergeant at Arms
11 and Doorkeeper, United States Senate.

12 SEC. 5. There are authorized such sums as may be
13 necessary for agency contributions related to the com-
14 pensation of employees of the committee from March 1,
15 2001, through September 30, 2001; October 1, 2001,
16 through September 30, 2002; and October 1, 2002,
17 through February 28, 2003, to be paid from the Appro-
18 priations account for “Expenses of Inquiries and Inves-
19 tigations”.
