AN ACT

To authorize appropriations for fiscal year 2004 for military construction, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

5 Authorization Act for Fiscal Year 2004”.

19 family housing and facilities, \$409,191,000.

21 (including the functions described in section

25 may not exceed the sum of—

 2 priated under paragraphs (1), and (2) of subsection
 3 (a);

4 (2) \$32,000,000 (the balance of the amount au-
 5 thorized under section 2101(a) for construction of a
 6 barracks, Fort Stewart, Georgia);

7 (3) \$87,000,000 (the balance of the amount au-
 8 thorized under section 2101(a) for construction of a
 9 Lewis and Clark instructional facility, Fort Leaven-
 10 worth, Kansas);

11 (4) \$43,000,000 (the balance of the amount au-
 12 thorized under section 2101(a) for the construction
 13 of a barracks complex, Wheeler-Sack Army Airfield,
 14 Fort Drum, New York); and

15 (5) \$50,000,000 (the balance of the amount au-
 16 thorized under section 2101(a) for construction of a
 17 barracks complex, Bastogne Drive, Fort Bragg,
 18 North Carolina).

15 **SEC. 2502. AUTHORIZATION OF APPROPRIATIONS, NATO.**

16 Funds are hereby authorized to be appropriated for
17 fiscal years beginning after September 30, 2003, for con-
18 tributions by the Secretary of Defense under section 2806
19 of title 10, United States Code, for the share of the United
20 States of the cost of projects for the North Atlantic Treaty
21 Organization Security Investment program authorized by
22 section 2501, in the amount of \$169,300,000.

TITLE XXVI—GUARD AND RESERVE FORCES FACILITIES

SEC. 2601. AUTHORIZED GUARD AND RESERVE CONSTRUCTION AND LAND ACQUISITION PROJECTS.

There are authorized to be appropriated for fiscal years beginning after September 30, 2003, for the costs of acquisition, architectural and engineering services, and construction of facilities for the Guard and Reserve Forces, and for contributions therefor, under chapter 1803 of title 10, United States Code (including the cost of acquisition of land for those facilities), the following amounts:

(1) For the Department of the Army—

(A) for the Army National Guard of the United States, \$276,779,000; and

(B) for the Army Reserve, \$74,478,000.

(2) For the Department of the Navy, for the Naval and Marine Corps Reserve, \$34,132,000.

(3) For the Department of the Air Force—

(A) for the Air National Guard of the United States, \$208,530,000; and

(B) for the Air Force Reserve, \$53,912,000.

 23 curity Investment program (and authorizations of appro-
 24 priations therefor) for which appropriated funds have been
 25 obligated before the later of—

1 (1) October 1, 2006; or

2 (2) the date of the enactment of an Act author-
 3 izing funds for fiscal year 2007 for military con-
 4 struction projects, land acquisition, family housing
 5 projects and facilities, and contributions to the
 6 North Atlantic Treaty Organization Security Invest-
 7 ment program.

8 **SEC. 2702. EXTENSION OF AUTHORIZATIONS OF CERTAIN**
 9 **FISCAL YEAR 2001 PROJECTS.**

10 (a) EXTENSION OF CERTAIN PROJECTS.—Notwith-
 11 standing section 2701 of the Floyd D. Spence National
 12 Defense Authorization Act for Fiscal Year 2001 (as en-
 13 acted into law by Public Law 106–398; 114 Stat. 1654A–
 14 407), authorizations set forth in the tables in subsection

1 CURITY.—The provisions of this section shall not apply to
 2 a building or property under the jurisdiction of the De-
 3 partment of Defense that the Secretary of Defense deter-

 5 government, or private entity, on a temporary basis, for
 6 emergency activities in support of homeland security.”.

7 **Subtitle C—Land Conveyances**

8 **SEC. 2821. TRANSFER OF LAND AT FORT CAMPBELL, KEN-** 9 **TUCKY AND TENNESSEE.**

10 (a) CONVEYANCE AUTHORIZED.—The Secretary of
 11 the Army may convey to the State of Tennessee, all right,
 12 title, and interest of the United States in and to a parcel
 13 of real property (right-of-way), including improvements
 14 thereon, located at Fort Campbell, Kentucky and Ten-
 15 nessee, for the purpose of realigning and upgrading
 16 United States Highway 79 from a 2-lane highway to a
 17 4-lane highway.

18 (b) CONSIDERATION.—

19 (1) PAYMENT.—As consideration for the con-
 20 veyance of the right-of-way parcel to be conveyed by
 21 subsection (a), the State of Tennessee shall pay
 22 from any source (including Federal funds made
 23 available to the State from the Highway Trust
 24 Fund) all of the Secretary’s costs associated with
 25 the following:

1 (A) COSTS OF CONVEYANCE.—The convey-
2 ance of the right-of-way parcel, including the
3 preparation of documents under the National
4 Environmental Policy Act of 1969 (42 U.S.C.
5 4321 et seq.), surveys (including surveys under
6 subsection (c)), appraisals, cultural reviews, ad-
7 ministrative expenses, cemetery relocation, and
8 other expenses necessary to transfer the prop-
9 erty.

10 (B) ACQUISITION OF REPLACEMENT
11 LAND.—The acquisition of approximately 200
12 acres of mission-essential replacement land re-
13 quired to support the training mission at Fort
14 Campbell.

15 (C) DISPOSAL OF RESIDUAL PROPERTY.—
16 The disposal of residual land located south of
17 the realigned highway.

18 (2) ACCEPTANCE AND CREDIT.—The Secretary
19 may accept funds under this subsection from the
20 Federal Highway Administration or the State of
21 Tennessee to pay the costs described in paragraph
22 (1) and shall credit the funds to the appropriate De-
23 partment of the Army accounts for the purpose of
24 paying such costs.

1 (3) PERIOD OF AVAILABILITY.—All funds ac-
 2 cepted by the Secretary under this subsection shall
 3 remain available until expended.

4 (c) DESCRIPTION OF PROPERTY.—The acreage of the
 5 real property to be conveyed, acquired, and disposed of
 6 under this section shall be determined by surveys satisfac-
 7 tory to the Secretary.

8 (d) ADDITIONAL TERMS AND CONDITIONS.—The
 9 Secretary may require such additional terms and condi-
 10 tions in connection with the conveyance under this section
 11 as the Secretary considers appropriate to protect the inter-
 12 ests of the United States.

13 **SEC. 2822. LAND CONVEYANCE, FORT KNOX, KENTUCKY.**

14 (a) CONVEYANCE AUTHORIZED.—The Secretary of
 15 the Army may convey, without consideration, to the De-
 16 partment of Veterans Affairs of the Commonwealth of
 17 Kentucky (in this section referred to as the “Depart-
 18 ment”), all right, title, and interest of the United States
 19 in and to a parcel of real property, including any improve-
 20 ments thereon, consisting of approximately 93 acres at
 21 Fort Knox, Kentucky, for the purpose of permitting the
 22 Department to establish and operate a State-run cemetery
 23 for veterans of the Armed Forces.

24 (b) REIMBURSEMENT FOR COSTS OF CONVEY-
 25 ANCE.—(1) The Department shall reimburse the Sec-

1 retary for any costs incurred by the Secretary in making
2 the conveyance authorized by subsection (a), including
3 costs related to environmental documentation and other
4 administrative costs. This paragraph does not apply to
5 costs associated with the environmental remediation of the
6 real property to be conveyed under such subsection.

7 (2) Any reimbursements received under paragraph
8 (1) for costs described in that paragraph shall be depos-
9 ited into the accounts from which the costs were paid, and
10 amounts so deposited shall be merged with amounts in
11 such accounts and available for the same purposes, and
12 subject to the same conditions and limitations, as the
13 amounts in such accounts with which merged.

14 (c) DESCRIPTION OF PROPERTY.—The exact acreage
15 and legal description of the real property to be conveyed
16 under subsection (a) shall be determined by a survey satis-
17 factory to the Secretary. The cost of the survey shall be
18 borne by the Department.

19 (d) ADDITIONAL TERMS AND CONDITIONS.—The
20 Secretary may require such additional terms and condi-
21 tions in connection with the conveyance under subsection
22 (a) as the Secretary considers appropriate to protect the
23 interests of the United States.

1 **SEC. 2823. LAND CONVEYANCE, MARINE CORPS LOGISTICS**
2 **BASE, ALBANY, GEORGIA.**

3 (a) CONVEYANCE AUTHORIZED.—The Secretary of
4 the Navy may convey through negotiated sale to the Pre-
5 ferred Development Group Corporation, a corporation in-
6 corporated in the State of Georgia and authorized to do
7 business in the State of Georgia (referred to in this section
8 as the “Corporation”), all right, title, and interest of the
9 United States in and to a parcel of real property, including
10 any improvements thereon, consisting of approximately
11 10.44 acres located at Boyett Village/Turner Field and
12 McAdams Road in Albany, Georgia, for the purpose of
13 permitting the Corporation to use the property for eco-
14 nomic development.

15 (b) CONDITIONS OF CONVEYANCE.—The conveyance
16 authorized under subsection (a) shall be subject to the fol-
17 lowing conditions:

18 (1) That the Corporation accept the real prop-
19 erty conveyed under subsection (a) as is.

20 (2) That the Corporation bear all costs related
21 to the use and redevelopment of the real property.

22 (c) CONSIDERATION.—As consideration for the con-
23 veyance authorized by subsection (a), the Corporation
24 shall pay the United States an amount, determined pursu-
25 ant to negotiations between the Secretary and the Cor-
26 poration and based upon the fair market value of the prop-

erty (as determined pursuant to an appraisal acceptable to the Secretary), that is appropriate for the property.

(d) REIMBURSEMENT FOR COSTS OF CONVEYANCE.—The Secretary may require the Corporation to reimburse the Secretary for any costs incurred by the Secretary in making the conveyance authorized by subsection (a).

(e) DEPOSIT OF AMOUNTS.—(1) The consideration received under subsection (c) shall be deposited in the Department of Defense Base Closure Account 1990 established by section 2906 of the Defense Base Closure and Realignment Act of 1990 (part A of title XXIX of Public Law 101-510; 10 U.S.C. 2687 note).

(2) Any reimbursements received under subsection (d) for costs described in that subsection shall be deposited into the accounts from which the costs were paid, and amounts so deposited shall be merged with amounts in such accounts and available for the same purposes, and subject to the same conditions and limitations, as the amounts in such accounts with which merged.

(f) EXEMPTION.—The conveyance authorized by subsection (a) shall be exempt from the requirement in section 2696 of title 10, United States Code, to screen the property for further Federal use.

1 (g) DESCRIPTION OF PROPERTY.—The exact acreage
 2 and legal description of the real property to be conveyed
 3 under subsection (a) shall be determined by a survey satis-
 4 factory to the Secretary.

5 (h) ADDITIONAL TERMS AND CONDITIONS.—The
 6 Secretary may require such additional terms and condi-
 7 tions in connection with the conveyance under subsection
 8 (a) as the Secretary considers appropriate to protect the
 9 interests of the United States.

10 **SEC. 2824. LAND CONVEYANCE, AIR FORCE AND ARMY EX-**
 11 **CHANGE SERVICE PROPERTY, DALLAS,**
 12 **TEXAS.**

13 (a) CONVEYANCE AUTHORIZED.—The Secretary of
 14 Defense may authorize the Army and Air Force Exchange
 15 Service to convey through negotiated sale all right, title,
 16 and interest of the United States in and to a parcel of
 17 real property, including any improvements thereon, con-
 18 sisting of approximately 7.5 acres located at 1515 Round-
 19 table Drive in Dallas, Texas.

20 (b) CONSIDERATION.—As consideration for the con-
 21 veyance authorized by subsection (a), the purchaser shall
 22 pay the United States a single payment equal to the fair
 23 market value of the real property, as determined pursuant
 24 to an appraisal acceptable to the Secretary.

1 (c) DEPOSIT OF AMOUNTS.—Section 574 of title 40,
 2 United States Code, shall apply to the consideration re-
 3 ceived under subsection (b), except that in the application
 4 of such section, all of the proceeds shall be returned to
 5 the Army and Air Force Exchange Service.

6 (d) DESCRIPTION OF PROPERTY.—The exact acreage
 7 and legal description of the real property to be conveyed
 8 under subsection (a) shall be determined by a survey satis-
 9 factory to the Secretary. The cost of the survey shall be
 10 borne by the purchaser.

11 (e) ADDITIONAL TERMS AND CONDITIONS.—The
 12 Secretary may require such additional terms and condi-
 13 tions in connection with the conveyance under subsection
 14 (a) as the Secretary considers appropriate to protect the
 15 interests of the United States.

16 **SEC. 2825. LAND EXCHANGE, NAVAL AND MARINE CORPS**
 17 **RESERVE CENTER, PORTLAND OREGON.**

18 (a) CONVEYANCE AUTHORIZED.—The Secretary of
 19 the Navy may convey to the United Parcel Service, Inc.
 20 (in this section referred to as “UPS”), any or all right,
 21 title, and interest of the United States in and to a parcel
 22 of real property, including improvements thereon, con-
 23 sisting of approximately 14 acres in Portland, Oregon, and
 24 comprising the Naval and Marine Corps Reserve Center

1 for the purpose of facilitating the expansion of the UPS
 2 main distribution complex in Portland.

3 (b) PROPERTY RECEIVED IN EXCHANGE.—(1) As
 4 consideration for the conveyance under subsection (a),
 5 UPS shall —

6 (A) convey to the United States a parcel of real
 7 property determined to be suitable by the Secretary;
 8 and

9 (B) design, construct, and convey such replace-
 10 ment facilities on the property conveyed under sub-
 11 paragraph (A) as the Secretary considers appro-
 12 priate.

13 (2) The value of the real property and replacement
 14 facilities received by the Secretary under this subsection
 15 shall be at least equal to the fair market value of the real
 16 property conveyed under subsection (a), as determined by
 17 the Secretary.

18 (c) PAYMENT OF COSTS OF CONVEYANCE.—(1) The
 19 Secretary may require UPS to cover costs to be incurred
 20 by the Secretary, or to reimburse the Secretary for costs
 21 incurred by the Secretary, to carry out the conveyance
 22 under subsection (a), including survey costs, costs related
 23 to environmental documentation, relocation expenses in-
 24 curred under subsection (b), and other administrative
 25 costs related to the conveyance. If amounts are collected

1 from UPS in advance of the Secretary incurring the actual
2 costs, and the amount collected exceeds the costs actually
3 incurred by the Secretary to carry out the conveyance, the
4 Secretary shall refund the excess amount to UPS.

5 (2) Amounts received as reimbursement under para-
6 graph (1) shall be credited to the fund or account that
7 was used to cover the costs incurred by the Secretary in
8 carrying out the conveyance. Amounts so credited shall be
9 merged with amounts in such fund or account, and shall
10 be available for the same purposes, and subject to the
11 same conditions and limitations, as amounts in such fund
12 or account.

13 (d) CONDITION OF CONVEYANCE.—The Secretary
14 may not make the conveyance authorized by subsection (a)
15 until the Secretary determines that the replacement facili-
16 ties required by subsection (b) are suitable and available
17 for the relocation of the operations of the Naval and Ma-
18 rine Corps Reserve Center.

19 (e) EXEMPTION FROM FEDERAL SCREENING.—The
20 conveyance authorized by subsection (a) is exempt from
21 the requirement to screen the property for other Federal
22 use pursuant to sections 2693 and 2696 of title 10, United
23 States Code.

24 (f) DESCRIPTION OF PROPERTY.—The exact acreage
25 and legal description of the property to be conveyed under

1 this section shall be determined by surveys satisfactory to
 2 the Secretary.

3 (g) **ADDITIONAL TERMS AND CONDITIONS.**—The
 4 Secretary may require such additional terms and condi-
 5 tions in connection with the conveyances under this section
 6 as the Secretary considers appropriate to protect the inter-
 7 ests of the United States.

8 **SEC. 2826. LAND CONVEYANCE, FORT RITCHIE, MARYLAND.**

9 (a) **CONVEYANCE AUTHORIZED.**—The Secretary of
 10 the Army shall convey, without consideration, to the
 11 PenMar Development Corporation, a public instrumen-
 12 tality of the State of Maryland (in this section referred
 13 to as the “Corporation”), all right, title, and interest of
 14 the United States in and to a parcel of real property, in-
 15 cluding improvements thereon, at former Fort Ritchie,
 16 Cascade, Maryland, consisting of approximately 33 acres,
 17 that is currently being leased by the International Ma-
 18 sonry Institute (in this section referred to as the “Insti-
 19 tute”), for the purpose of enabling the Corporation to sell
 20 the property to the Institute for the economic development
 21 of former Fort Ritchie.

22 (b) **EXEMPTION FROM FEDERAL SCREENING RE-**
 23 **QUIREMENT.**—The conveyance authorized by subsection
 24 (a) shall be exempt from the requirement to screen the
 25 property concerned for further Federal use pursuant to

1 section 2696 of title 10, United States Code, under the
 2 Defense Base and Realignment Act of 1990 (part A of
 3 title XXIX of Public Law 101–510; 10 U.S.C. 2687 note)
 4 or under any other applicable law or regulation.

5 (c) DESCRIPTION OF PROPERTY.—The exact acreage
 6 and legal description of the real property to be conveyed
 7 under subsection (a) shall be determined by a survey satis-
 8 factory to the Secretary. The cost of the survey shall be
 9 borne by the Corporation.

10 (d) ADDITIONAL TERMS AND CONDITIONS.—The
 11 Secretary may require such additional terms and condi-
 12 tions in connection with the conveyance under subsection
 13 (a) as the Secretary considers appropriate to protect the
 14 interests of the United States.

15 **SEC. 2827. FEASIBILITY STUDY OF CONVEYANCE OF LOU-**
 16 **ISIANA ARMY AMMUNITION PLANT, DOYLINE,**
 17 **LOUISIANA.**

18 (a) STUDY REQUIRED.—(1) The Secretary of the
 19 Army shall conduct a study of the feasibility, costs, and
 20 benefits for the conveyance of the Louisiana Army Ammu-
 21 nition Plant as a model for a public-private partnership
 22 for the utilization and development of the Plant and simi-
 23 lar parcels of real property.

24 (2) In conducting the study, the Secretary shall
 25 consider—

1 (A) the feasibility and advisability of entering
2 into negotiations with the State of Louisiana or the
3 Louisiana National Guard for the conveyance of the
4 Plant;

5 (B) means by which the conveyance of the
6 Plant could—

7 (i) facilitate the execution by the Depart-
8 ment of Defense of its national security mis-
9 sion; and

10 (ii) facilitate the continued use of the
11 Plant by the Louisiana National Guard and the
12 execution by the Louisiana National Guard of
13 its national security mission;

14 (C) evidence presented by the State of Lou-
15 isiana of the means by which the conveyance of the
16 Plant could benefit current and potential private sec-
17 tor and governmental tenants of the Plant and fa-
18 cilitate the contribution of such tenants to economic
19 development in Northwestern Louisiana;

20 (D) the amount and type of consideration that
21 is appropriate for the conveyance of the Plant;

22 (E) the evidence presented by the State of Lou-
23 isiana of the extent to which the conveyance of the
24 Plant to a public-private partnership will contribute

1 to economic growth in the State of Louisiana and in
2 Northwestern Louisiana in particular;

3 (F) the value of any mineral rights in the lands
4 of the Plant; and

5 (G) the advisability of sharing revenues and
6 rents paid by current and potential tenants of the
7 Plant as a result of the Armament Retooling and
8 Manufacturing Support Program.

9 (b) LOUISIANA ARMY AMMUNITION PLANT.—In this
10 section, the term “Louisiana Army Ammunition Plant”
11 means the Louisiana Army Ammunition Plant in Doyline,
12 Louisiana, consisting of approximately 14,949 acres, of
13 which 13,665 acres are under license to the Military De-
14 partment of the State of Louisiana and 1,284 acres are
15 used by the Army Joint Munitions Command.

16 (c) REPORT.—Not later than 180 days after the date
17 of the enactment of this Act, the Secretary shall submit
18 to the Committees on Armed Services of the Senate and
19 the House or Representatives a report on the study con-
20 ducted under subsection (a). The report shall include the
21 results of the study and any other matters in light of the
22 study that the Secretary considers appropriate.

1 **Subtitle D—Review of Overseas**
2 **Military Facility Structure**

3 **SEC. 2841. SHORT TITLE.**

4 This subtitle may be cited as the “Overseas Military
5 Facility and Range Structure Review Act of 2003”.

6 **SEC. 2842. ESTABLISHMENT OF COMMISSION.**

7 (a) ESTABLISHMENT.—There is established the Com-
8 mission on the Review of the Overseas Military Facility
9 and Range Structure of the United States (in this subtitle
10 referred to as the “Commission”).

11 (b) MEMBERSHIP.—(1) The Commission shall be
12 composed of 9 members of whom—

13 (A) one shall be appointed by the Secretary of
14 Defense;

15 (B) two shall be appointed by the Majority
16 Leader of the Senate, in consultation with the
17 Chairman of the Committee on Armed Services of
18 the Senate and the Chairman of the Subcommittee
19 on Defense of the Committee on Appropriations of
20 the Senate;

21 (C) two shall be appointed by the Minority
22 Leader of the Senate, in consultation with the Rank-
23 ing Member of the Committee on Armed Services of
24 the Senate and the Ranking Member of the Sub-

1 committee on Defense of the Committee on Appro-
2 priations of the Senate;

3 (D) two shall be appointed by the Speaker of
4 the House of Representatives, in consultation with
5 the Chairman of the Committee on Armed Services
6 of the House of Representatives and the Chairman
7 of the Subcommittee on Defense of the Committee
8 on Appropriations of the House of Representatives;
9 and

10 (E) two shall be appointed by the Minority
11 Leader of the House of Representatives, in consulta-
12 tion with the Ranking Member of the Committee on
13 Armed Services of the House of Representatives and
14 the Ranking Member of the Subcommittee on De-
15 fense of the Committee on Appropriations of the
16 House of Representatives.

17 (2) Individuals appointed to the Commission shall
18 have significant experience in the national security or for-
19 eign policy of the United States.

20 (3) Appointments of the members of the Commission
21 shall be made not later than 45 days after the date of
22 the enactment of this Act.

23 (c) PERIOD OF APPOINTMENT; VACANCIES.—Mem-
24 bers shall be appointed for the life of the Commission. Any
25 vacancy in the Commission shall not affect its powers, but

1 shall be filled in the same manner as the original appoint-
2 ment.

3 (d) INITIAL MEETING.—Not later than 30 days after
4 the date on which all members of the Commission have
5 been appointed, the Commission shall hold its first meet-
6 ing.

7 (e) MEETINGS.—The Commission shall meet at the
8 call of the Chairman.

9 (f) QUORUM.—A majority of the members of the
10 Commission shall constitute a quorum, but a lesser num-
11 ber of members may hold hearings.

12 (g) CHAIRMAN AND VICE CHAIRMAN.—The Commis-
13 sion shall select a Chairman and Vice Chairman from
14 among its members.

15 **SEC. 2843. DUTIES OF COMMISSION.**

16 (a) STUDY.—The Commission shall conduct a thor-
17 ough study of matters relating to the military facility and
18 range structure of the United States overseas.

19 (b) MATTERS TO BE STUDIED.—In conducting the
20 study, the Commission shall—

21 (1) assess the number of military personnel of
22 the United States required to be based outside the
23 United States;

24 (2) examine the current state of the military fa-
25 cilities and training ranges of the United States

1 overseas for all permanent stations and deployed lo-
2 cations, including the condition of land and improve-
3 ments at such facilities and ranges and the avail-
4 ability of additional land, if required, for such facili-
5 ties and ranges;

6 (3) identify the amounts received by the United
7 States, whether in direct payments, in-kind contribu-
8 tions, or otherwise, from foreign countries by reason
9 of military facilities of the United States overseas;

10 (4) assess whether or not the current military
11 basing and training range structure of the United
12 States overseas is adequate to meet the current and
13 future mission of the Department of Defense, in-
14 cluding contingency, mobilization, and future force
15 requirements;

16 (5) assess the feasibility and advisability of the
17 closure or realignment of military facilities of the
18 United States overseas, or the establishment of new
19 military facilities of the United States overseas, to
20 meet the requirements of the Department of Defense
21 to provide for the national security of the United
22 States; and

23 (6) consider or assess any other issue relating
24 to military facilities and ranges of the United States
25 overseas that the Commission considers appropriate.

1 (c) REPORT.—(1) Not later than August 30, 2004,
2 the Commission shall submit to the President and Con-
3 gress a report which shall contain a detailed statement of
4 the findings and conclusions of the Commission, together
5 with its recommendations for such legislation and admin-
6 istrative actions as it considers appropriate.

7 (2) In addition to the matters specified in paragraph
8 (1), the report shall also include a proposal by the Com-
9 mission for an overseas basing strategy for the Depart-
10 ment of Defense in order to meet the current and future
11 mission of the Department.

12 **SEC. 2844. POWERS OF COMMISSION.**

13 (a) HEARINGS.—The Commission may hold such
14 hearings, sit and act at such times and places, take such
15 testimony, and receive such evidence as the Commission
16 considers advisable to carry out this subtitle.

17 (b) INFORMATION FROM FEDERAL AGENCIES.—The
18 Commission may secure directly from any Federal depart-
19 ment or agency such information as the Commission con-
20 sidered necessary to carry out this subtitle. Upon request
21 of the Chairman of the Commission, the head of such de-
22 partment or agency shall furnish such information to the
23 Commission.

24 (c) ADMINISTRATIVE SUPPORT SERVICES.—Upon re-
25 quest of the Commission, the Administrator of General

1 Services shall provide to the Commission, on a reimburs-
2 able basis, the administrative support necessary for the
3 Commission to carry out its duties under this subtitle.

4 (d) **POSTAL SERVICES.**—The Commission may use
5 the United States mails in the same manner and under
6 the same conditions as other departments and agencies of
7 the Federal Government.

8 (e) **GIFTS.**—The Commission may accept, use, and
9 dispose of gifts or donations of services or property.

10 **SEC. 2845. COMMISSION PERSONNEL MATTERS.**

11 (a) **COMPENSATION OF MEMBERS.**—Each member of
12 the Commission who is not an officer or employee of the
13 Federal Government shall be compensated at a rate equal
14 to the daily equivalent of the annual rate of basic pay pre-
15 scribed for level IV of the Executive Schedule under sec-
16 tion 5315 of title 5, United States Code, for each day (in-
17 cluding travel time) during which such member is engaged
18 in the performance of the duties of the Commission under
19 this subtitle. All members of the Commission who are offi-
20 cers or employees of the United States shall serve without
21 compensation in addition to that received for their services
22 as officers or employees of the United States.

23 (b) **TRAVEL.**—(1) Members of the Commission shall
24 be allowed travel expenses, including per diem in lieu of
25 subsistence, at rates authorized for employees of agencies

1 under subchapter I of chapter 57 of title 5, United States
2 Code, while away from their homes or regular places of
3 business in the performance of services for the Commis-
4 sion under this subtitle.

5 (2) Members and staff of the Commission may receive
6 transportation on aircraft of the Military Airlift Command
7 to and from the United States, and overseas, for purposes
8 of the performance of the duties of the Commission to the
9 extent that such transportation will not interfere with the
10 requirements of military operations.

11 (c) STAFF.—(1) The Chairman of the Commission
12 may, without regard to the civil service laws and regula-
13 tions, appoint and terminate an executive director and
14 such other additional personnel as may be necessary to
15 enable the Commission to perform its duties under this
16 subtitle. The employment of an executive director shall be
17 subject to confirmation by the Commission.

18 (2) The Commission may employ a staff to assist the
19 Commission in carrying out its duties. The total number
20 of the staff of the Commission, including an executive di-
21 rector under paragraph (1), may not exceed 12.

22 (3) The Chairman of the Commission may fix the
23 compensation of the executive director and other personnel
24 without regard to chapter 51 and subchapter III of chap-
25 ter 53 of title 5, United States Code, relating to classifica-

tion of positions and General Schedule pay rates, except that the rate of pay for the executive director and other personnel may not exceed the rate payable for level V of the Executive Schedule under section 5316 of such title.

(d) DETAIL OF GOVERNMENT EMPLOYEES.—Any employee of the Department of Defense, the Department of State, or the General Accounting Office may be detailed to the Commission without reimbursement, and such detail shall be without interruption or loss of civil service status or privilege.

(e) PROCUREMENT OF TEMPORARY AND INTERMITTENT SERVICES.—The Chairman of the Commission may procure temporary and intermittent services under section 3109(b) of title 5, United States Code, at rates for individuals which do not exceed the daily equivalent of the annual rate of basic pay prescribed for level V of the Executive Schedule under section 5316 of such title.

SEC. 2846. SECURITY.

(a) SECURITY CLEARANCES.—Members and staff of the Commission, and any experts and consultants to the Commission, shall possess security clearances appropriate for their duties with the Commission under this subtitle.

(b) IN GENERAL.—The Secretary of Defense shall assume responsibility for the handling and disposition of any information relating to the national security of the United

1 States that is received, considered, or used by the Commis-
 2 sion under this subtitle.

3 **SEC. 2847. TERMINATION OF COMMISSION.**

4 The Commission shall terminate 45 days after the
 5 date on which the Commission submits its report under
 6 section 2843(c).

7 **SEC. 2848. FUNDING.**

8 (a) IN GENERAL.—Of the amount authorized to be
 9 appropriated by section 301(5) for the Department of De-
 10 fense for operation and maintenance, Defense-wide,
 11 \$3,000,000 shall be available to the Commission to carry
 12 out this subtitle.

13 (b) AVAILABILITY.—The amount authorized to be ap-
 14 propriated by subsection (a) shall remain available, with-
 15 out fiscal year limitation, until September 30, 2005.
