Mr. MCCAIN (for himself, Mr. GRAHAM of South Carolina, and Mr. ALLEN) introduced the following bill; which was read twice and referred to the Committee on Armed Services

A BILL

To amend title 10, United States Code, to provide Survivor Benefit Plan annuities for surviving spouses of Reserves not eligible for retirement who die from a cause incurred or aggravated while on inactive-duty training.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SURVIVOR BENEFIT PLAN ANNUITIES FOR SUR-**
 2 **VIVING SPOUSES OF RESERVES NOT ELIGI-**
 3 **BLE FOR RETIREMENT WHO DIE FROM A**
 4 **CAUSE INCURRED OR AGGRAVATED WHILE**
 5 **ON INACTIVE-DUTY TRAINING.**

6 (a) SURVIVING SPOUSE ANNUITY.—Paragraph (1) of
 7 section 1448(f) of title 10, United States Code, is amend-
 8 ed to read as follows:

9 “(1) SURVIVING SPOUSE ANNUITY.—The Sec-
 10 retary concerned shall pay an annuity under this
 11 subchapter to the surviving spouse of—

12 “(A) a person who is eligible to provide a
 13 reserve-component annuity and who dies—

14 “(i) before being notified under sec-
 15 tion 12731(d) of this title that he has com-
 16 pleted the years of service required for eli-
 17 gibility for reserve-component retired pay;
 18 or

19 “(ii) during the 90-day period begin-
 20 ning on the date he receives notification
 21 under section 12731(d) of this title that he
 22 has completed the years of service required
 23 for eligibility for reserve-component retired
 24 pay if he had not made an election under
 25 subsection (a)(2)(B) to participate in the
 26 Plan; or

1 “(B) a member of a reserve component not
2 described in subparagraph (A) who dies from
3 an injury or illness incurred or aggravated in
4 the line of duty during inactive-duty training.”.

5 (b) CONFORMING AMENDMENT.—The heading for
6 subsection (f) of section 1448 of such title is amended by
7 inserting “OR BEFORE” after “DYING WHEN”.

8 (c) EFFECTIVE DATE.—The amendments made by
9 this section shall take effect as of September 10, 2001,
10 and shall apply with respect to performance of inactive-
11 duty training (as defined in section 101(d) of title 10,
12 United States Code) on or after that date.
