## AN ACT

To authorize a comprehensive program of support for victims of torture, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Torture Victims Relief  
5 Reauthorization Act of 2003”.

1 **SEC. 2. AUTHORIZATION OF APPROPRIATIONS FOR FOR-**  
 2 **EIGN TREATMENT CENTERS FOR VICTIMS OF**  
 3 **TORTURE.**

4 (a) AUTHORIZATION OF APPROPRIATIONS.—Section  
 5 4(b)(1) of the Torture Victims Relief Act of 1998 (22  
 6 U.S.C. 2152 note) is amended to read as follows:

7 “(1) AUTHORIZATION OF APPROPRIATIONS.—Of  
 8 the amounts authorized to be appropriated for fiscal  
 9 years 2004, 2005, and 2006 pursuant to chapter 1  
 10 of part I of the Foreign Assistance Act of 1961 (22  
 11 U.S.C. 2151 et seq.) there are authorized to be ap-  
 12 propriated to the President to carry out section 130  
 13 of such Act \$11,000,000 for fiscal year 2004,  
 14 \$12,000,000 for fiscal year 2005, and \$13,000,000  
 15 for fiscal year 2006.”.

16 (b) EFFECTIVE DATE.—The amendment made by  
 17 subsection (a) shall take effect October 1, 2003.

18 **SEC. 3. AUTHORIZATION OF APPROPRIATIONS FOR THE**  
 19 **UNITED STATES CONTRIBUTION TO THE**  
 20 **UNITED NATIONS VOLUNTARY FUND FOR**  
 21 **VICTIMS OF TORTURE.**

22 Of the amounts authorized to be appropriated for fis-  
 23 cal years 2004, 2005, and 2006 pursuant to chapter 3  
 24 of part I of the Foreign Assistance Act of 1961 (22 U.S.C.  
 25 2221 et seq.), there are authorized to be appropriated to  
 26 the President for a voluntary contribution to the United

1 Nations Voluntary Fund for Victims of Torture  
 2 \$6,000,000 for fiscal year 2004, \$7,000,000 for fiscal year  
 3 2005, and \$8,000,000 for fiscal year 2006.

4 **SEC. 4. AUTHORIZATION OF APPROPRIATIONS FOR DOMES-**  
 5 **TIC TREATMENT CENTERS FOR VICTIMS OF**  
 6 **TORTURE.**

7 (a) AUTHORIZATION OF APPROPRIATIONS.—Section  
 8 5(b)(1) of the Torture Victims Relief Act of 1998 (22  
 9 U.S.C. 2152 note) is amended to read as follows:

10 “(1) AUTHORIZATION OF APPROPRIATIONS.—Of  
 11 the amounts authorized to be appropriated for the  
 12 Department of Health and Human Services for fis-  
 13 cal years 2004, 2005, and 2006, there are author-  
 14 ized to be appropriated to carry out subsection (a)  
 15 \$20,000,000 for fiscal year 2004, \$25,000,000 for  
 16 fiscal year 2005, and \$30,000,000 for fiscal year  
 17 2006.”.

18 (b) EFFECTIVE DATE.—The amendment made by  
 19 subsection (a) shall take effect October 1, 2003.
