Mr. MCHUGH (for himself, Mr. TOM DAVIS of Virginia, Mr. WAXMAN, and Mr. DAVIS of Illinois) introduced the following bill; which was referred to the Committee on Government Reform

A BILL

To amend title 39, United States Code, to make cigarettes and certain other tobacco products nonmailable.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. NONMAILABILITY OF CERTAIN TOBACCO PROD-**
4 **UCTS.**

5 (a) IN GENERAL.—Chapter 30 of title 39, United
6 States Code, is amended by inserting after section 3002a
7 the following:

8 **“§ 3002b. Nonmailability of certain tobacco products**

9 “(a) IN GENERAL.—Cigarettes, smokeless tobacco,
10 pipe tobacco, and roll-your-own-tobacco—

1 “(1) are nonmailable matter;

2 “(2) shall not be—

3 “(A) deposited in the mails; or

4 “(B) carried or delivered through the
5 mails; and

6 “(3) shall be disposed of as the Postal Service
7 directs.

8 “(b) CIVIL PENALTY.—Any person who violates sub-
9 section (a)(2)(A) shall be liable to the United States for
10 a civil penalty in an amount not to exceed \$100,000 for
11 each violation.

12 “(c) HEARINGS.—The Postal Service may determine
13 that a person has violated subsection (a) only after notice
14 and an opportunity for a hearing. Proceedings under this
15 subsection shall be conducted in accordance with section
16 3001(m).

17 “(d) PENALTY CONSIDERATIONS.—In determining
18 the amount of a civil penalty under this section, the Postal
19 Service shall consider—

20 “(1) the nature, circumstances, extent, and
21 gravity of the violation;

22 “(2) with respect to the violator, the degree of
23 culpability, ability to pay, and any history of prior
24 violations; and

25 “(3) such other matters as justice may require.

1 “(e) CIVIL ACTIONS TO COLLECT.—A civil action
 2 may be brought in an appropriate district court of the
 3 United States, in accordance with section 409(d), to col-
 4 lect a civil penalty under this section.

5 “(f) DISPOSITION OF AMOUNTS.—Amounts received
 6 in payment of any civil penalties under this section shall
 7 be deposited as miscellaneous receipts in the Treasury of
 8 the United States.

9 “(g) DEFINITIONS.—For purposes of this section, the
 10 terms ‘cigarette’, ‘smokeless tobacco’, ‘pipe tobacco’, and
 11 ‘roll-your-own-tobacco’ have the meanings given them by
 12 section 5702 of the Internal Revenue Code of 1986.”.

13 (b) CLERICAL AMENDMENT.—The table of sections
 14 for chapter 30 of title 39, United States Code, is amended
 15 by inserting after the item relating to section 3002a the
 16 following:

“3002b. Nonmailability of certain tobacco products.”.

17 **SEC. 2. EFFECTIVE DATE.**

18 The amendments made by section 1 shall take effect
 19 60 days after the date of the enactment of this Act, and
 20 shall apply with respect to any mail matter mailed on or
 21 after that effective date.
