## A BILL

To liquidate or reliquidate certain entries of frozen fish fillets.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION. 1. LIQUIDATION OR RELIQUIDATION OF CERTAIN**  
4 **ENTRIES OF FROZEN FISH FILLETS.**

5 (a) LIQUIDATION OR RELIQUIDATION OF ENTRIES.—

6 Notwithstanding sections 514, 520, and 751 of the Tariff  
7 Act of 1930 (19 U.S.C. 1514, 1520, and 1675) or any  
8 other provision of law, the Bureau of Customs and Border  
9 Protection shall, not later than 90 days after the date of  
10 enactment of this Act—

1           (1) liquidate or reliquidate the entries listed in  
 2           subsection (b) at the rate of duty, value, quantity,  
 3           and amount of duties asserted at the time of entry  
 4           by the importer of record; and

5           (2) refund any antidumping duties and interest  
 6           paid on such entries.
