Mr. MENENDEZ introduced the following bill; which was read twice and referred to the Committee on Finance

A BILL

To provide for the liquidation or reliquidation of certain apparel articles entered from February 7, 2005, to March 16, 2005, under the United States-Caribbean Basin Trade Partnership Act.

1 *Be it enacted by the Senate and House of Representa-*

2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CERTAIN ENTRIES OF APPAREL ARTICLES.**

4 (a) IN GENERAL.—Notwithstanding section 514 of

5 the Tariff Act of 1930 (19 U.S.C. 1514) or any other pro-

6 vision of law, the Bureau of Customs and Border Protec-

7 tion shall, not later than 90 days after the receipt of the

1 request described in subsection (b), liquidate or reliquidate
 2 as free of duty the entries described in subsection (d).

3 (b) REQUEST.—Liquidation or reliquidation may be
 4 made under subsection (a) with respect to an entry de-
 5 scribed in subsection (d) only if a request is filed with the
 6 Bureau of Customs and Border Protection not later than
 7 120 days after the date of the enactment of this Act.

8 (c) REFUND OF AMOUNTS OWED.—Any amounts
 9 owed by the United States pursuant to the liquidation or
 10 reliquidation of the entries described in subsection (d) (in-
 11 cluding interest from the date of entry) shall be refunded
 12 not later than 90 days after the date of such liquidation
 13 or reliquidation.
