## A BILL

To suspend temporarily the duty on certain girls' water  
resistant pants.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. CERTAIN GIRLS' WATER RESISTANT PANTS.**

4       (a) IN GENERAL.—

5               (1) Chapter 61 of the Harmonized Tariff  
6       Schedule of the United States is amended by insert-  
7       ing in numerical sequence, the following statistical  
8       note:

9       “7. For the purposes of subheadings 6103.43.15,  
10   6104.63.20, and 6113.00.90, the term ‘performance out-  
11   erwear pants’ means ankle length pants of water resistant

1 synthetic fabrics, containing at least two of the following  
 2 characteristics: side openings, sealed seams at the front  
 3 (up to the zipper or other means of closure) and the back  
 4 rise, insulation for cold weather protection, at least one  
 5 pocket with a means of closure (zippered or hook and loop  
 6 enclosed pockets or other type of enclosed pockets), scuff  
 7 guards, elasticized or drawstring weather closure around  
 8 the waist or ankles, articulated knees, or reinforcement  
 9 in the seat or knees. The term ‘water resistant’ means  
 10 a garment, notwithstanding classification, that would oth-  
 11 erwise pass the test for water resistance described in U.S.  
 12 note 2 to chapter 62. The term ‘sealed seams’ means a  
 13 seam that is sealed by means of taping, gluing, bonding,  
 14 cementing, or similar processes for the purpose of water-  
 15 proofing the seam.”.

16 (2) Subchapter II of chapter 99 of the Har-  
 17 monized Tariff Schedule of the United States is  
 18 amended by inserting in numerical sequence the fol-  
 19 lowing new heading:
