Mr. DEMINT introduced the following bill; which was read twice and referred to the Committee on Finance

A BILL

To suspend temporarily the duty on certain women's and girls' water resistant pants.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 **SECTION 1. CERTAIN WOMEN'S AND GIRLS' WATER RESIST-**
4 **ANT PANTS.**

5 (a) IN GENERAL.—
6 (1) Chapter 61 of the Harmonized Tariff
7 Schedule of the United States is amended by insert-
8 ing in numerical sequence, the following statistical
9 note:

1 “7. For the purposes of subheadings 6103.43.15,
 2 6104.63.20, and 6113.00.90, the term ‘performance out-
 3 erwear pants’ means ankle length pants of water resistant
 4 synthetic fabrics, containing at least two of the following
 5 characteristics: side openings, sealed seams at the front
 6 (up to the zipper or other means of closure) and the back
 7 rise, insulation for cold weather protection, at least one
 8 pocket with a means of closure (zippered or hook and loop
 9 enclosed pockets or other type of enclosed pockets), scuff
 10 guards, elasticized or drawstring weather closure around
 11 the waist or ankles, articulated knees, or reinforcement
 12 in the seat or knees. The term ‘water resistant’ means
 13 a garment, notwithstanding classification, that would oth-
 14 erwise pass the test for water resistance described in U.S.
 15 note 2 to chapter 62. The term ‘sealed seams’ means a
 16 seam that is sealed by means of taping, gluing, bonding,
 17 cementing, or similar processes for the purpose of water-
 18 proofing the seam.”.

19 (2) Subchapter II of chapter 99 of the Har-
 20 monized Tariff Schedule of the United States is
 21 amended by inserting in numerical sequence the fol-
 22 lowing new heading:

1 (b) EFFECTIVE DATE.—The amendment made by
2 subsection (a) applies to goods entered, or withdrawn from
3 warehouse for consumption, on or after the 15th day after
4 the date of the enactment of this Act.
