A BILL

To provide for the liquidation or reliquidation of certain entries of educational toys entered in October 21 through November 14, 2003.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CERTAIN ENTRIES OF EDUCATIONAL TOYS EN-**
4 **TERED IN OCTOBER 21 THROUGH NOVEMBER**
5 **14, 2003.**

6 (a) IN GENERAL.—Notwithstanding section 514 of
7 the Tariff Act of 1930 (19 U.S.C. 1514) or any other pro-
8 vision of law, upon proper request filed with the Bureau
9 of Customs and Border Protection within 180 days after
10 the date of the enactment of this Act, the Bureau of Cus-

1 toms and Border Protection shall liquidate or reliquidate
 2 each entry described in subsection (c) as duty free.

3 (b) REFUND OF AMOUNTS OWED.—Any amounts
 4 owed by the United States pursuant to a request for liq-
 5 uidation or reliquidation of an entry under subsection (a)
 6 shall be paid with interest not later than 180 days after
 7 the date on which the request is made.
