Mr. CHAMBLISS introduced the following bill; which was read twice and referred to the Committee on Finance

A BILL

To provide for the liquidation or reliquidation of certain entries relating to high-density, fiberboard-core laminate panels entered in February 2003 through May 2003.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. ENTRIES OF CERTAIN HIGH-DENSITY, FIBER-**
4 **BOARD-CORE LAMINATE PANELS ENTERED**
5 **IN FEBRUARY 2003 THROUGH MAY 2003.**

6 (a) IN GENERAL.—Notwithstanding section 514 of
7 the Tariff Act of 1930 (19 U.S.C. 1514) or any other pro-
8 vision of law, the Bureau of Customs and Border Protec-
9 tion shall, not later than 90 days after the receipt of the

1 request described in subsection (b), liquidate or reliquidate
 2 the entries described in subsection (d) at a rate of duty
 3 of 1.9 cents per kilogram plus 1.5 percent ad valorem.

4 (b) REQUEST.—Liquidation or reliquidation may be
 5 made under subsection (a) with respect to an entry de-
 6 scribed in subsection (d) only if a request is filed with the
 7 Bureau of Customs and Border Protection not later than
 8 90 days after the date of the enactment of this Act.

9 (c) REFUND OF AMOUNTS OWED.—Any amounts
 10 owed by the United States pursuant to the liquidation or
 11 reliquidation of an entry described in subsection (d) (in-
 12 cluding interest from the date of entry) shall be refunded
 13 not later than 90 days after the date of such liquidation
 14 or reliquidation.
