which was read twice and referred to the Committee on Finance

## A BILL

To amend title XVIII of the Social Security Act to make  
a technical correction in the definition of outpatient  
speech-language pathology services.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. TECHNICAL CORRECTION IN THE DEFINITION**  
4                       **OF OUTPATIENT SPEECH-LANGUAGE PA-**  
5                       **THOLOGY SERVICES.**

6           (a) IN GENERAL.—Section 1861(ll) of the Social Se-  
7       curity Act (42 U.S.C. 1395x(ll)) is amended—

8                       (1) by redesignating paragraphs (2) and (3) as  
9       paragraphs (3) and (4), respectively; and

1           (2) by inserting after paragraph (1) the fol-  
 2           lowing new paragraph:

3           “(2) The term ‘outpatient speech-language pa-  
 4           thology services’ has the meaning given the term  
 5           ‘outpatient physical therapy services’ in subsection  
 6           (p), except that in applying such subsection—

7                   “(A) ‘speech-language pathology’ shall be  
 8                   substituted for ‘physical therapy’ each place it  
 9                   appears; and

10                   “(B) ‘speech-language pathologist’ shall be  
 11                   substituted for ‘physical therapist’ each place it  
 12                   appears.”.

13           (b) CONFORMING AMENDMENTS.—(1) Section  
 14   1861(p) of the Social Security Act (42 U.S.C. 1395x(p))  
 15   is amended by striking the fourth sentence.

16           (2) Section 1833(a)(8)(A) of the Social Security Act  
 17   (42 U.S.C. 1395l(a)(8)(A)) is amended by striking “out-  
 18   patient physical therapy services (which includes out-  
 19   patient speech-language pathology services) and out-  
 20   patient occupational therapy services” and inserting “out-  
 21   patient physical therapy services, outpatient speech-lan-  
 22   guage pathology services, and outpatient occupational  
 23   therapy services”.

24           (3) Section 1833(a)(8)(B) of the Social Security Act  
 25   (42 U.S.C. 1395l(a)(8)(B)) is amended by striking “out-

1 patient physical therapy services (which includes out-  
2 patient speech-language pathology services) and out-  
3 patient occupational therapy services” and inserting “out-  
4 patient physical therapy services, outpatient speech-lan-  
5 guage pathology services, and outpatient occupational  
6 therapy services”.

7       (c) EFFECTIVE DATE.—The amendments made by  
8 this section shall apply to services provided on or after  
9 the date that is 6 months after the date of enactment of  
10 this Act.
