AN ACT

To require the Secretary of the Treasury to mint coins in commemoration of the bicentennial of the birth of Abraham Lincoln.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Abraham Lincoln Com-
5 memorative Coin Act”.

1 **SEC. 2. FINDINGS.**

2 The Congress finds as follows:

3 (1) Abraham Lincoln, the 16th President, was
4 one of the Nation's greatest leaders, demonstrating
5 true courage during the Civil War, one of the greatest
6 crises in the Nation's history.7 (2) Born of humble roots in present-day LaRue
8 County, Kentucky, on February 12, 1809, Abraham
9 Lincoln rose to the Presidency through a combination
10 of honesty, integrity, intelligence, and commitment
11 to the United States.12 (3) With the belief that all men were created
13 equal, Abraham Lincoln led the effort to free all
14 slaves in the United States.15 (4) Abraham Lincoln had a generous heart,
16 with malice toward none and with charity for all.17 (5) Abraham Lincoln gave the ultimate sacrifice
18 for his country, dying from an assassin's bullet on
19 April 15, 1865.20 (6) The year 2009 will be the bicentennial anniversary
21 of the birth of Abraham Lincoln.22 (7) The Abraham Lincoln Bicentennial Commission
23 has been charged by Congress with planning
24 the celebration of President Lincoln's bicentennial.

4 SEC. 3. COIN SPECIFICATIONS.

5 (a) \$1 SILVER COINS.—The Secretary of the Treas-
6 ury (in this Act referred to as the “Secretary”) shall mint
7 and issue not more than 500,000 \$1 coins, which shall—
8 (1) weigh 26.73 grams;
9 (2) have a diameter of 1.500 inches; and
10 (3) contain 90 percent silver and 10 percent
11 copper.

12 (b) **LEGAL TENDER.**—The coins minted under this
13 Act shall be legal tender, as provided in section 5103 of
14 title 31, United States Code.

15 (c) NUMISMATIC ITEMS.—For purposes of sections
16 5134 and 5136 of title 31, United States Code, all coins
17 minted under this Act shall be considered to be numis-
18 matic items.

19 SEC. 4. DESIGN OF COINS.

20 (a) DESIGN REQUIREMENTS.—

21 (1) IN GENERAL.—The design of the coins
22 minted under this Act shall be emblematic of the life
23 and legacy of President Abraham Lincoln.

6 (b) SELECTION.—The design for the coins minted

7 under this Act shall be—

11 (2) reviewed by the Citizens Coinage Advisory
12 Committee established under section 5135 of title
13 31, United States Code.

14 SEC. 5. ISSUANCE OF COINS.

15 (a) QUALITY OF COINS.—Coins minted under this
16 Act shall be issued in uncirculated and proof qualities.

17 (b) MINT FACILITY.—Only 1 facility of the United
18 States Mint may be used to strike any particular quality
19 of the coins minted under this Act.

20 (c) PERIOD FOR ISSUANCE.—The Secretary may
21 issue coins minted under this Act only during the 1-year
22 period beginning on January 1, 2009.

1 **SEC. 6. SALE OF COINS.**

2 (a) **SALE PRICE.**—The coins minted under this Act
3 shall be sold by the Secretary at a price equal to the sum
4 of—

5 (1) the face value of the coins;
6 (2) the surcharge provided in section 7(a) with
7 respect to such coins; and
8 (3) the cost of designing and issuing the coins
9 (including labor, materials, dies, use of machinery,
10 overhead expenses, marketing, and shipping).

11 (b) **BULK SALES.**—The Secretary shall make bulk
12 sales of the coins minted under this Act at a reasonable
13 discount.

14 (c) **PREPAID ORDERS.**—

15 (1) **IN GENERAL.**—The Secretary shall accept
16 prepaid orders for the coins minted under this Act
17 before the issuance of such coins.

18 (2) **DISCOUNT.**—Sale prices with respect to pre-
19 paid orders under paragraph (1) shall be at a rea-
20 sonable discount.

21 **SEC. 7. SURCHARGES.**

22 (a) **IN GENERAL.**—All sales of coins minted under
23 this Act shall include a surcharge of \$10 per coin.

24 (b) **DISTRIBUTION.**—Subject to section 5134(f) of
25 title 31, United States Code, all surcharges received by
26 the Secretary from the sale of coins minted under this Act

1 shall be promptly paid by the Secretary to the Abraham
2 Lincoln Bicentennial Commission to further the work of
3 the Commission.

4 (c) AUDITS.—The Abraham Lincoln Bicentennial
5 Commission shall be subject to the audit requirements of
6 section 5134(f)(2) of title 31, United States Code.
