Authorizing expenditures by the Select Committee on Intelligence.

Mr. ROCKEFELLER, from the Select Committee on Intelligence, reported the following original resolution; which was referred to the Committee on Rules and Administration

---

## RESOLUTION

Authorizing expenditures by the Select Committee on  
Intelligence.

1       *Resolved,*

2       **SECTION 1. AUTHORITY TO MAKE EXPENDITURES.**

3       In carrying out its powers, duties, and functions  
4       under Senate Resolution 400, agreed to May 19, 1976  
5       (94th Congress), as amended by Senate Resolution 445,  
6       agreed to October 9, 2004 (108th Congress), in accord-  
7       ance with its jurisdiction under section 3 and section 17  
8       of such Senate Resolution 400, including holding hearings,  
9       reporting such hearings, and making investigations as au-  
10      thorized by section 5 of such Senate Resolution 400, the

1 Select Committee on Intelligence is authorized during the  
 2 periods from March 1, 2007, through September 30,  
 3 2007, from October 1, 2007, through September 30, 2008,  
 4 and from October 1, 2008, through February 28, 2009,  
 5 in the Committee's discretion—

6 (1) to make expenditures from the contingent  
 7 fund of the Senate;

8 (2) to employ personnel; and

9 (3) with the prior consent of the department or  
 10 agency of the United States concerned and the Com-  
 11 mittee on Rules and Administration, to use on a re-  
 12 imburseable or nonreimbursable basis, the services of  
 13 personnel of any such department or agency.

14 **SEC. 2. AMOUNT OF EXPENDITURES.**

15 (a) MARCH 1, 2007, THROUGH SEPTEMBER 30,  
 16 2007.—The expenses of the Select Committee on Intel-  
 17 ligence for the period March 1, 2007, through September  
 18 30, 2007, under this resolution shall not exceed  
 19 \$3,334,682.15, of which amount—

20 (1) not to exceed \$32,083.00 may be expended  
 21 for the procurement of the services of individual con-  
 22 sultants, or organizations thereof (as authorized by  
 23 section 202(i) of the Legislative Reorganization Act  
 24 of 1946 (2 U.S.C. 72a(i)); and

1           (2) not to exceed \$5,834.00 may be expended  
2       for the training of the professional staff of such  
3       Committee (under procedures specified by section  
4       202(j) of the Legislative Reorganization Act of 1946  
5       (2 U.S.C. 72a(j)).

6       (b) OCTOBER 1, 2007, THROUGH SEPTEMBER 30,  
7       2008.—For the period October 1, 2007, through Sep-  
8       tember 30, 2008, expenses of the Select Committee on In-  
9       telligence under this resolution shall not exceed  
10      \$5,848,084.42, of which amount—

11           (1) not to exceed \$55,000.00 may be expended  
12      for the procurement of the services of individual con-  
13      sultants or organizations thereof (as authorized by  
14      section 202(i) of the Legislative Reorganization Act  
15      of 1946 (2 U.S.C. 72a(i)); and

16           (2) not to exceed \$10,000.00 may be expended  
17      for the training of the professional staff of such  
18      Committee (under procedures specified by section  
19      202(j) of the Legislative Reorganization Act of 1946  
20      (2 U.S.C. 72a(j)).

21       (c) OCTOBER 1, 2008, THROUGH FEBRUARY 28,  
22       2009.—For the period October 1, 2008, through February  
23       28, 2009, expenses of the Select Committee on Intelligence  
24       under this resolution shall not exceed \$2,483,179.75, of  
25       which amount—

1           (1) not to exceed \$22,917.00 may be expended  
2           for the procurement of the services of individual con-  
3           sultants, or organizations thereof (as authorized by  
4           section 202(i) of the Legislative Reorganization Act  
5           of 194 (2 U.S.C. 72a(i)); and

6           (2) not to exceed \$4,166.00 may be expended  
7           for the training of the professional staff of such  
8           Committee (under procedures specified by section  
9           202(j) of the Legislative Reorganization Act of 1946  
10          (2 U.S.C. 72a(j)).

11 **SEC. 3. REPORT.**

12          The Select Committee on Intelligence shall report the  
13          Committee's findings, together with such recommenda-  
14          tions for legislation as the Committee deems advisable, to  
15          the Senate at the earliest practicable date, but not later  
16          than February 28, 2009.

17 **SEC. 4. EXPENSES PAID FROM THE CONTINGENT FUND.**

18          Expenses of the Select Committee on Intelligence au-  
19          thorized to be paid under this resolution shall be paid from  
20          the contingent fund of the Senate upon vouchers approved  
21          by the chairman of the Committee, except that vouchers  
22          shall not be required—

23                (1) for the disbursement of salaries of employ-  
24          ees paid at an annual rate;

1           (2) for the payment of telecommunications pro-  
2       vided by the Office of the Sergeant at Arms and  
3       Doorkeeper, United States Senate;

4           (3) for the payment of stationery supplies pur-  
5       chased through the Keeper of the Stationery, United  
6       States Senate;

7           (4) for payments to the Postmaster, United  
8       States Senate;

9           (5) for the payment of metered charges on  
10      copying equipment provided by the Office of the Ser-  
11      geant at Arms and Doorkeeper, United States Sen-  
12      ate;

13          (6) for the payment of Senate Recording and  
14      Photographic Services; or

15          (7) for payment of franked and mass mail costs  
16      by the Sergeant at Arms and Doorkeeper, United  
17      States Senate.

18 **SEC. 5. AUTHORITY FOR AGENCY CONTRIBUTIONS.**

19      There are authorized such sums as may be necessary  
20      for agency contributions related to the compensation of  
21      employees of the Select Committee on Intelligence, from  
22      March 1, 2007, through September 30, 2007, from Octo-  
23      ber 1, 2007, through September 30, 2008, and from Octo-  
24      ber 1, 2008, through February 28, 2009, to be paid from

- 1 the Appropriations account for “Expenses of Inquiries and
- 2 Investigations”.
