CONCURRENT RESOLUTION

To direct the Architect of the Capitol to place a marker in Emancipation Hall in the Capitol Visitor Center which acknowledges the role that slave labor played in the construction of the United States Capitol, and for other purposes.

3 **SECTION 1. FINDINGS.**

4 Congress finds the following:

5 (1) Enslaved African-Americans provided labor
6 essential to the construction of the United States
7 Capitol.

18 (6) Slave-quarried stones from the remnants of
19 the original Capitol walls can be found in Rock
20 Creek Park in the District of Columbia.

3 (8) The great hall of the Capitol Visitor Center
4 was named Emancipation Hall to help acknowledge
5 the work of the slave laborers who built the Capitol.

6 (9) No narrative on the construction of the
7 Capitol that does not include the contribution of
8 enslaved African-Americans can fully and accurately
9 reflect its history.

10 (10) Recognition of the contributions of
11 enslaved African-Americans brings to all Americans
12 an understanding of the continuing evolution of our
13 representative democracy.

14 (11) A marker dedicated to the enslaved Afri-
15 can-Americans who helped to build the Capitol will
16 reflect the charge of the Capitol Visitor Center to
17 teach visitors about Congress and its development.

18 **SEC. 2. PLACEMENT OF MARKER IN CAPITOL VISITOR CEN-**
19 **TER TO ACKNOWLEDGE ROLE OF SLAVE**
20 **LABOR IN CONSTRUCTION OF CAPITOL.**

21 (a) PROCUREMENT AND PLACEMENT OF MARKER.—
22 The Architect of the Capitol, subject to the approval of
23 the Committee on House Administration of the House of
24 Representatives and the Committee on Rules and Admin-
25 istration of the Senate, shall design, procure, and place

1 in a prominent location in Emancipation Hall in the Cap-
2 itol Visitor Center a marker which acknowledges the role
3 that slave labor played in the construction of the United
4 States Capitol.

5 (b) CRITERIA FOR DESIGN OF MARKER.—In devel-
6 oping the design for the marker required under subsection
7 (a), the Architect of the Capitol shall—

8 (1) take into consideration the recommenda-
9 tions developed by the Slave Labor Task Force
10 Working Group;

11 (2) to the greatest extent practicable, ensure
12 that the marker includes stone which was quarried
13 by slaves in the construction of the Capitol; and

14 (3) ensure that the marker includes a plaque or
15 inscription which describes the purpose of the mark-
16 er.
