A BILL

To amend the Internal Revenue Code of 1986 to modify the tax rate for excise tax on investment income of private foundations.

1 *Be it enacted by the Senate and House of Representa-
2 tives of the United States of America in Congress assembled,*

3 **SECTION 1. MODIFICATION OF THE TAX RATE FOR THE EX-
4 CISE TAX ON INVESTMENT INCOME OF PRI-
5 VATE FOUNDATIONS.**

6 (a) IN GENERAL.—Subsection (a) of section 4940 of
7 the Internal Revenue Code of 1986 is amended by striking
8 “2 percent” and inserting “1.39 percent”.

1 (b) ELIMINATION OF REDUCED TAX WHERE FOUN-
2 DATION MEETS CERTAIN DISTRIBUTION REQUIRE-
3 MENTS.—Section 4940 of the Internal Revenue Code of
4 1986 is amended by striking subsection (e).

5 (c) EFFECTIVE DATE.—The amendments made by
6 this section shall apply to taxable years beginning after
7 the date of the enactment of this Act.
