Mr. CULBERSON (for himself, Mr. CHABOT, Mr. HULTGREN, Mr. MCKINLEY, and Mr. THOMPSON of Pennsylvania) introduced the following bill; which was referred to the Committee on Oversight and Government Reform, and in addition to the Committee on Appropriations, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To save at least \$10,000,000,000 by consolidating some duplicative and overlapping Government programs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CONSOLIDATING UNNECESSARY DUPLICATIVE**
4 **AND OVERLAPPING GOVERNMENT PRO-**
5 **GRAMS.**

6 Notwithstanding any other provision of law, not later
7 than 150 days after the date of enactment of this Act,
8 the Director of the Office of Management and Budget

1 shall coordinate with the heads of the relevant department
2 and agencies to—

3 (1) use available administrative authority to
4 eliminate, consolidate, or streamline Government
5 programs and agencies with duplicative and overlap-
6 ping missions identified in—

7 (A) the February 2012 Government Ac-
8 countability Office report to Congress, entitled
9 “Opportunities to Reduce Duplication, Overlap
10 and Fragmentation, Achieve Savings, and En-
11 hance Revenue” (GAO-12-342SP); and

12 (B) the March 2011 Government Account-
13 ability Office report to Congress, entitled “Op-
14 portunities to Reduce Potential Duplication in
15 Government Programs, Save Tax Dollars, and
16 Enhance Revenue” (GAO-11-318SP) and
17 apply the savings towards deficit reduction;

18 (2) identify and report to Congress any legisla-
19 tive changes required to further eliminate, consoli-
20 date, or streamline Government programs and agen-
21 cies with duplicative and overlapping missions identi-
22 fied in—

23 (A) the February 2012 Government Ac-
24 countability Office report to Congress, entitled
25 “Opportunities to Reduce Duplication, Overlap

1 and Fragmentation, Achieve Savings, and En-
2 hance Revenue” (GAO–12–342SP); and

3 (B) the March 2011 Government Account-
4 ability Office report to Congress, entitled “Op-
5 portunities to Reduce Potential Duplication in
6 Government Programs, Save Tax Dollars, and
7 Enhance Revenue” (GAO–11–318SP);

8 (3) determine the total cost savings that shall
9 result to each agency, office, and department from
10 the actions described in paragraph (1); and

11 (4) rescind from the appropriate accounts the
12 amount greater of—

13 (A) \$10,000,000,000; or

14 (B) the total amount of cost savings esti-
15 mated by paragraph (3).
